The purpose of this amendment is to clarify the responses to some of the questions below which were not addressed (in error) in the previous amendment 001.

This amendment is posted to respond to the following questions:

Q1. The close date for the RFP is listed as June 8, 2015 while in implementation date listed in Section 6 (E) is June 1 2015. Can you please clarify?

A1. The implementation date did not get updated in the specifications. The implementation date, or the 'up and running date', should be changed from June 01, to July 31, 2015.

Q2. Who is the incumbent (third party) providing these services today? If you are unable to provide a name can you confirm whether the managed services today are performed by Canada or a third party?

A2. AG Research Inc., Sydney, NS

Q3. Why is the term for 1 year only? Would PWGSC consider a longer term such as 3 or 5 years?

A3. The initial term is for 1 year only, with options for two additional years.

Q4. Our company is interested in bidding on this RPF (Solicitation No. E0225-15-2224). I see that the bids are due 8 June 2008. When will the contract be awarded and when will you need the SharePoint environment to be available?

A4. See also Question 1. The contract will be awarded approximately the first week of July 2015 and the up and running date is approximately July 31, 2015.
