Question 21.

We are unclear as to the function of selecting metropolitan areas and regions. As the professional services we are applying to provide under this supply arrangement are able to be provided remotely, we would be able to provide services to anywhere from our head office. This would likely result in us selecting the National Zone. However, if we were to select all Regions and Metropolitan areas, would that mean we are confirming that we currently have personnel in all of those regions and metropolitan areas? Or is this to confirm that if an agency or department procuring under the supply chain requested that personnel be located in a specific metropolitan area or region that we would pay for the travel and accommodation of personnel to those regions (if we didn't already have personnel there)?

Answer 21.

Yes this is correct, by selecting National Zone you are identifying that you wish to offer services from your location only. Identified users would use this region (zone) in their search criteria if it was irrelevant to the requirement that the contractor be in any specific region to perform the work. For further definition please refer to page 33 of the RFSA document, ATTACHMENT C TECHNICAL RESPONSE TEMPLATE / CPSS SUPPLIER MODULE - DATA COLLECTION COMPONENT (DCC).

Question 22.

If we have 'Protected B – need to know' status for our DOS/FSC security clearance, do we answer 'Protected B-DOS' for the question on DOS/FSC Document Safeguarding, or do we leave this as 'None'?

Answer 22.

If you currently have Document Safeguarding - Protected B level, you would indicate this under "DOS/FSC Document Safeguarding:" in the DCC under **Certification - Security**. Under **Certification -**

Security Sponsorship you would indicate 'none' unless you were requesting an upgrade to your current level.
