In the ANNEX G - MANDATORY TECHNICAL CRITERIA section 7.0:

"Certified Matrox System Builder" for Matrox MX02. It does not exist anymore. They stopped the certified system builder with the Matrox Axio LE. A bidder cannot be compliant to a certification that does not exist anymore for the MX02.

Answer 1:

The bidder's observation is definitely valid. The Matrox Video Products Group never had the "Certified System Builder" classification for MX02, or any products in the MX02 family. We are removing the Certified Matrox System Builder.
