The following changes in the bid documents are effective immediately.
This addendum will form part of the contract documents.

SPECIFICATIONS

1 Section 01 00 10 - General Instructions

- .1 Add new article 1.3.5 as follows: The contractor will be issued a 'stop work' order during special events taking place in the building.
- .2 Add new article 1.3.6 as follows: Construction cannot start before June 29th, 2015.
- .3 Add new article 1.6.4.5 as follows: The fire alarm does not need to be bypassed during the performance of dusty work.
- .4 Add new article 1.9.7 as follows: The contractor must access the building from Sparks Street through the Booth Building entrance located at 165 Sparks Street. The contractor will not have access to the loading dock.
- .5 Delete article 1.17.1 in it's entirety and replace with: The contractor is not required to cover the costs associated with security guard escorts; however the contractor must give the departmental representative 48hrs notice in advance of the work, in order to schedule the security guard escort.
