Page 45 of 76 section 1.8 "Warranty" requirement states, "Warranty Period, Materials" as First 15 years: 100 percent of the material supply and installation labour.

Page 45 of 76 Part 2, "Manufacturers", states that IKO, BP, GAF, Certaineed & Owens Corning are approved manufacturers.

My questions, or more of a comment only two of the listed Manufacturer's meet the requirement for 15 years @ 100%, they are BP and IKO. The other manufacturers provide 10 years @100%. Now the concern I have is, the two manufacturers (IKO & BP) that give you 15years @100%, make the poorest quality shingles, of the manufacturers listed. Also, when/if you need warranty, they have a poor track record of servicing their customers.

Point .2 states This specification is based on products by IKO. Comparable products from manufacturers listed herein will be accepted provided they meet requirements of this specification.

Can this requirement be adjusted to 10 years @100%?



Response from the Real Property Asset Manager:

10 years is a reasonable amount of time. I support changing this to 10 years at 100%. to provide a broader choice of products.

All other terms and conditions to remain the same.
