1. EXTENSION OF TIME

Notice is hereby given that the time for the reception of tenders previously due June 2, 2015 is hereby extended to **14:00 hours, June 4, 2015.**

2. QUESTIONS AND ANSWERS

Q1: Should we include the "Former Public Servant" section with the Certifications?

A1: Yes.

Q2: The bids must be returned by mail or courier to 189 Prince William Street, room 405, Saint John, New Brunswick, E2L 2B9. It states in section 2.2 that the bids must be submitted only to PWGSC Bid Receiving Unit. Are these the same?

A2: Yes.

Q3: For the Certifications Section, do we have to print the documents requested? Such as the Provisions on the integrity and Federal Contractors Program for Employment Equity - Certification offer? Or should we just sign the three spaces on Page 14?

A3: Section 5.1.1 Integrity Provisions states, "By submitting an offer, the offeror certifies that the Offeror and its Affiliates are in compliance with the provision as stated in Section 01 Integrity Provision - Offer or Standard Instructions 2006." In relation to this, Annex C requires offerors to provide a list of directors/owners of their company.

Section 5.1.2 - Federal Contractors Program for Employment Equity states, "By submitting an offer, the Offeror certifies that the Offeror, and any of the Offeror's members if the Offeror is a Joint Venture is not named on the Federal Contractors Program (FCP) for employment Equity "FCP Limited Eligibility to Bid" list..." Offerors are not required to provide anything additional.

The three spaces on Page 14 should be signed and provided with the offer.

Q4: Reference is made to the Security Requirements Check List in Appendix E. Are we required to complete this document? What other documents related to security should be completed?

A4: Offerors are not required to complete the Security Requirement Check List. No other documents related to security are required at time of closing.

3. REQUEST FOR A STANDING OFFER DOCUMENT

Cover Page:
