This amendment is issued in response to the following questions.

1. The cleaning service is required 5 days per week, however snow shovelling is required 7 days per week. Is this correct?

**Answer:** That is correct.

2. Is cleaning on holidays required?

**Answer:** No requirement.

3. There is a requirement for the contractor to provide 4 vacuum cleaners and a carpet extractor at the Hospital. There did not appear to be any carpet at the site. Is this requirement correct?

**Answer:** There are no carpets; however, it is a requirement to be available in case the areas become carpeted. It doesn't have to be in the building at the time until needed. Yes, we need 4 vacuums.
