A1 – In regard to the Certifications identified in Part 5 – Certifications, Bidders may certify as identified below:

- **Integrity Provisions - Associated Information**
Bidders are to provide a complete list of names of all individuals who are currently Directors of the Bidder;
- **Federal Contractors Program for Employment Equity - Bid Certification**
Certified by Bidder through bid submission;
- **Canadian Content Certification**
Bidders are to complete the Canadian Content Certification in Section 5.1.3.1.1 of the Request for Proposal; and
- **Status and Availability of Resources**
Certified by Bidder through bid submission. Statements of certification are also acceptable.

All Certifications are to be provided in a separately bound section.

All other terms and conditions of the solicitation remain the same.
