#### A. Questions and Answers

#### Q4. Do suppliers need to dismantle the existing shelves?

A4. Yes, as per Annex A: Statemement of Requirement, section 6.0 Tasks, where it states that the Contractor is responsible for the following: 6.3 Dismantling the current shelving listed under Appendix A: Existing Shelving Inventory, prior to installation.

## Q5. Can CRA supply the AutoCAD drawing file with the bond room dimensions?

A5. Yes, CRA can provide this to anyone that is interested in receiving this version. The document cannot be posted on Buy and Sell, so if required, please send an email to the Contracting Authority, as identified on page 10 of the RFP, and they will ensure that a version is emailed to you.

## Q6. Where can the shelving be stored when installing the track floor?

A6. Assuming that the existing shelving is being referred to here, CRA will make room in the warehouse area on the first floor as the phases are being completed. It must also be understood that the decking will have to be done in phases along with the shelving.

#### Q7. Where in building can the uprights be cut down to size?

A7. CRA will be responsible for providing a place for this work to take place. It is possible that the work can be conducted outside of the loading dock or something similar.

## Q8. Can the inventory be double checked, as it appears that there is an issue with the U1 (36") quantities on the drawing?

A8. The inventory was double checked and is correct. The confusion may stem from the fact that U1 represents the 16 x 42" shelving, not the 36" shelving, which is associated with U3. Hopefully this will clarify the discrepency.

### Q9. How many Phases will there be?

A9. CRA had estimated three phases for the installation, but if this can be completed in two phases, this is acceptable as well.

- Q10. The start date of the install date and the completed install date is very short can this be adjusted?
- A10. The installation can start as soon as the Bidder is able to complete the manufacturing process and delivery. If it is felt that there is not enough reasonable time scheduled for the delivery and installation, than the vendor must provide CRA with the standard times required for this size of project, for both the delivery and the installation, and CRA will take this into consideration.
- Q11. In Annex A: Statement of Requirement of the RFP, under Section 5.0 Product Specifications, sub-section 5.3 Carriages, CRA stated the following:
  - 5.3.1 The carriages must consist of welded 12 gauge steel construction, designed and manufactured to support weight without distortion.

    <u>Galvinized structural components and/or riveted carriages are unacceptable.</u>

The assembly process that has been excluded is the base of our design and has exceeded the standard of the industry for over 50 years. We also believe that the use of welded components is proprietary to another manufacturer.

Based on this, can galvanized structural components and /or riveted carriages be accepted for this requirement?

- A11. CRA will accept galvanized structural components and/or riveted carriages, provided that this does not impact the structure's weight capacity, or other product specifications that the carriage must meet. Please refer to Amendment #6 to the RFP to view this correction. This change will apply to Appendix C: Mandatory Performance Specifications as well.
- Q12. For previous Federal Government RFP's where the environment has contained sensitive information, there have been mandatory requirements to provide installation team's where each person on site has Reliability security clearance. As this project is for the CRA, and the room contains boxes of sensitive information, can you please confirm if reliability security clearance will be a mandatory requirement?
- A12. CRA will be escorting all Contractor personnel while on the CRA premises, and only CRA personnel will be authorized to handle the materials stored within the Bond Room; therefore the reliability security clearance will not be required for Contractor personnel in this instance.

## B. Amendment to the Request for Proposal (RFP)

Amend #6. In Annex A: Statement of Requirement, under section 5.0 Product Specifications, subsection 5.3 Carriages, located on page 36 of 44:

## **DELETE** the following:

5.3.1 The carriages must consist of welded 12 gauge steel construction, designed and manufactured to support weight without distortion. Galvinized structural components and/or riveted carriages are unacceptable.

## **INSERT** the following:

5.3.1 The carriages must consist of welded 12 gauge steel construction, designed and manufactured to support weight without distortion. Galvinized structural components and/or riveted carriages will also be accepted, but not prefered.
