QUESTIONS AND ANSWERS

Q1: How should we demonstrate the number of years we have been providing nursing staff?

A1: By providing the date the Agency started providing nurses to clients.

Q2: If we want to assign a nurse who has worked at Ste-Anne's within the past two years, does the nurse still have to complete the 7.5 hour orientation period?

A2: Orientation is mandatory if main nursing procedures charges occurred in the meantime.

Q3: We note that the services provider will be withdrawn from the offer after four refusals. Can you please specify over what period of time?

A3: Four months.

Q4: If there are any legislated increases to our costs as the employer, will we be permitted to increase the billing rates accordingly?

A4: No. Rates provided are fixed over the period of the Standing Offer or option year.
