This Amendment #003 is raised to answer questions raised on Solicitation #F2407-150007/A as follows:

Question #1

Would Department of Fisheries and Oceans (DFO) accept 30 cm resolution imagery instead of 10 cm resolution imagery as outlining in the Aerial Photography Services RFP?

Answer #1

No, DFO requires 10 cm resolution.

Question #2

Will DFO require the contractor to have approval from Transport Canada under CAR702 Canadian Air Regulations - (aerial photography operations) with the proof of a company OC (Operating Certificate)?

Answer #2

The contractor is to ensure that all required certifications, insurances, registrations, licenses, and documentation are current and maintained and are available upon request with relation to the work to be performed.

Question #3

Will DFO require that the contractor's aircraft be COMMERCIALY registered?

Answer #3

It is the contractor's responsibility to ensure they have all required certifications, insurances, registrations, licenses, and documentation that is needed for the manner in which the contractor intends to fulfill their obligation under the contract, and to ensure compliance with any applicable law.

Question #4

Is it a requirement of DFO that the contractor's camera installations meet Transport Canada standards via STC (Supplemental Type Certifications) certifications?

Answer #4

The contractor is to ensure that all required certifications, insurances, registrations, licenses, and documentation are current and maintained and are available upon request with relation to the work to be performed.

Question #5

Will DFO require that the contractor's pilot training requirements meet commercial operator standards and that they have Transport Canada PPC's on their licenses (Pilot Proficiency Check)
