2. **Bidders' Questions and Answers set**

Q.25 Can you confirm that the only certification required under Part 5, Certifications, is the Integrity Provision certification? All other required certifications will be flowed down during the resulting Bid Solicitation process for any successful supply arrangement bidders?

A.25 Yes. For the RFSA, the only certification required under Part 5 - CERTIFICATIONS is the Integrity Provision certification, detailed at section 5.1.1.

Bid Solicitations for specific requirements under the Supply Arrangement will call for certifications as applicable to the specific requirement.

Q.26 Background

Per text in Annex F, section 4.2, 'statement' d.:

"d. Once a Bidder is qualified in a Cable category, the requirement for a sample cable assembly will in no way relieve the Bidder, as Contractor, from the duty of strictly adhering to the technical requirements of the bid solicitation or any resultant contract under the SA. Written confirmation must be provided by the Bidder with the sample cable, stating that, should the Bidder be awarded a contract, the technical requirement as defined in that contract will be strictly adhered to in the manufacture of the required cables."

Question:

Can the Crown please provide the format and text required for the highlighted certification, defining precisely what PWGSC expect to see with the sample cables?

- A.26** Supplier's own format in print ("written confirmation"), and the text of the Supplier's certification must satisfy the statement made at 4.2 d.

Suppliers must provide one such certification for each copper cable qualification sample submitted with their arrangement.

****NOTE:** The Supplier's statement/certification should include:

- reference to the qualification sample cable part number per Appendix A1;
- the Supplier company name, and
- signature of a duly authorized representative of the Supplier making that statement/certification.

Q27: Background:

RFSA Part 3.1 Arrangement Preparation Instructions has the following text:

"Section IV: Additional Information (two (2) hard copies and one (1) soft copy readable on Microsoft Office 2003 Suite or Adobe PDF format on CD-ROM or DVD)."

Question:

The RFSA does not appear to be an explanation of what PWGSC expects for content in Section IV: Additional Information. Please provide direction on what PWGSC expects to see as content for Section IV: Additional Information.

- A.27** At RFSA Part 3.1, Sections "I" through "IV" are a representation of the standard format of Arrangements submitted by suppliers. Within this format, all of the submission requirements must be addressed.

For the purposes of this RFSA, Part 3 Section 3.3 ARRANGEMENT CONTENT, describes the requirements that **must** be addressed, and the applicable sections.

Should an arrangement submission include additional information not specifically required in sections 3.3.1, 3.3.2, or 3.3.3, it would be the subject of a "Section IV".

All other terms and conditions remain unchanged.
