Question 1.

Also, would consideration be given to starting the morning meeting at 10:00AM to allow some additional time buffer to get to the meeting from Schwartz Bay on the 7:00-8:35AM ferry?

Response 1.

The Mandatory Site Visit will include an opportunity to view underneath the deck of the South Jetty (at two locations, one on the foreshore and one on the catwalk), with lighting and commentary provided by PWGSC personnel.

The start time for the Mandatory Bidder's Conference and for the Mandatory Site Visit will not be changed.
