Amendment No. 001

This amendment is being raised to (1) incorporate revisions to the RFP, and (2) provide responses to Requests for Clarification.

(1) RFP REVISIONS

Required Services (RS), RS2 Construction and Contract Administration

Reference: 2.3.16 Environmental Testing and Monitoring

Delete: In its entirety

Insert: In-water work will generally consist of sheet pile driving, debris removal along the sheet pile driving line, dredging between the sheet pile walls.

Within three weeks after award of this Construction Engineering Services contract, the Consultant shall provide the Departmental Representative with an Environmental Quality Monitoring Plan for review and approval, which will include as a minimum, details of water quality and air quality monitoring. Further details are provided below:

(2) REQUESTS FOR CLARIFICATION

Q1. RFP Page 27 Section 2.3.16 Environmental Testing and Monitoring – The RFP specifies that “prior to tender award, the Consultant shall provide the Departmental Representative with an Environmental Quality Monitoring Plan for review and approval...”. Given that the Construction and the Consultant contracts are both awarded in July 2015 (Appendix E), can the PWGSC confirm when the Consultant is required to provide this Plan during the Contract schedule? In addition, where does the cost of this item occur, in the RS1 Fixed Fee or in the RS2 Construction and Contract Administration stage?

A1. The Consultant is required to provide the plan within three weeks after award of this Construction Engineering Services contract. Please see RFP REVISIONS (1) above.

This item is covered under RS 2 Construction and Contract Administration of Appendix C – Price Proposal Form.

Q2. RFP Page 48 – Section RS 3A: Under item 6, there is a reference to the completion of a bathymetric survey during the construction stage. Can PWGSC confirm if this scope of work is included in the Construction Engineering Services contract? If so, please advise regarding the price item this is to be addressed under in the Price Proposal Form - Appendix C?

A2. The bathymetric surveys are included in the Construction Engineering Services contract under RS 2 Construction and Contract Administration, 2.3.12 Work Measurement and 2.3.15 Inspection and Testing; and RS 3 Resident Site Services During Construction, 3.12 Inspections and Testing.

The price for the bathymetric surveys are covered under RS 2 Construction and Contract Administration; and under RS 3 Resident Site Services During Construction of Appendix C – Price Proposal Form.

The price for the survey boat is covered under RS3A Consultant Site Office/Trailer(s) and Boat(s) of Appendix C – Price Proposal Form.

Q3. RFP Page 74 – Appendix C – Section RS 3A: Does PWGSC has any requirements or specifications for the boat to be supplied under this cost item, or is this up to the consultant to decide?

A3. The Consultant is required to provide a boat or alternatively more than one boat that is suitable for carrying out the tasks for Contract Site Supervision including sampling, testing and bathymetric surveying. The Consultant's boat(s) is/are required to transport up to four people designated by the Departmental Representative once a week for approximately 2 hours for the duration of the contract.

Q4. RFP Page 74 – Section RS3A – Estimated Weeks for the Consultant Site Office/Trailer is specified at 120 weeks, vs. the Boat for 100 weeks, vs. page 75 Point 2 where the construction period is based on an estimated 100 weeks. In addition, page 15 of the RFP Section 2.4 Schedule indicates 29 months and the previous 2014 RFP specified 24 months/100 weeks. Can PWGSC please confirm the duration of the Construction Engineering contract schedule and the units provided in the Appendix C Cost Proposal Form?

A4. The duration of the Construction Engineering Services contract is twenty-nine (29) months. For the proposals evaluation purpose, PWGSC assume the Consultant Site Office/Trailer is for 120 weeks and the Boat(s) is for 100 weeks.

Q5. RFP Page 78 Cost Proposal Form Section C Disbursements indicates “travel for the consultant/engineer to review the steel fabrication in the US”. Can the PWGSC please confirm the location of the steel fabricator in the US?

A5. The steel fabricator in the US is located in luka, Mississippi.

Q6. Please provide the construction drawings and construction scope of work specification to allow bidders to fully understand the work.
