Amendment number 002 to Request for Standing Offer (RFSO) E60HL-140050/F which closes June 22, 2015 at 2:00 p.m. is raised to:

Incorporate into the solicitation the following questions and answers.

Question 1:

The volume stated for Ottawa Airport is 500,000 litres Jet A-1 and 5,955,000 litres Jet A-1 with FSII. This is the same volume that was in the original tender last year. Presumably the volume would be half that now for the remaining year of the standing offer? Kindly confirm the estimated quantity required for the remainder of the standing offer period.

Answer to question 1:

Volumes shown in Request for Standing Offer E60HL-140050/F are two year volume estimates. Therefore, estimated volumes for the remainder of the standing offer period are approximately half of the two year estimates shown.

Question 2:

In the tender document it states that the requirements are on an as and when requested basis by the Identified User, from date of issuance of standing offer up to and including May 31, 2016. Could you please provide further details about when the date of issuance of standing offer might be and how much notice will be given to the supplier before the first call up would be?

Answer to question 2:

Canada would be looking to work with the winning offeror in order to get the standing offer in place by July 1, 2015. Canada does understand that the winning offeror would need time to set up accounts and the July 1st date might not be realistic.

All other terms and conditions of the Request for Standing Offers remain unchanged.
