BidCentral Online Bidding for Subcontractors Sections and Divisions

(Bonding required as per the BidCentral Online Bidding for Subcontractors Rules of Procedure)

Electrical

Combined bids only to include:

Division 26 - Electrical

Division 28 - Electronic Safety and Security

Section 33 31 76 Direct Buried Underground Cable Ducts (See Note 1)

BOBS Rules of Procedure, Appendix A Standard Exclusions for Electrical shall apply. General Contractors are to include as they deem necessary for any work excluded by a Trade Contractor.

Note 1: Clarification - Appendix A Standard Exclusions require Electrical Bidders to exclude (but not limited to) precast concrete pullboxes/manholes, excavation and backfill.
