GENERAL INFORMATION

1.0 PROJECT SUMMARY

Corporate Management Branch of Agriculture and Agri-Food Canada (AAFC) is the owner/operator of infrastructure and land associated with twenty nine (29) water storage projects in southern Saskatchewan. These works were among the many built between 1935 and 1960 as part of PFRA's legislated mandate to help stabilize and contribute to the economic security of the drought prone regions of western Canada. Gouverneur Dam is located near the Towns of Ponteix and Cadillac, Saskatchewan, and provides irrigation, stock watering, recreation, flood protection, rural domestic and municipal water supplies for the area. Braddock Dam is located near the Village of Braddock, Saskatchewan and provides water for irrigation, stock watering and recreation.

AAFC manages these dams in accordance with the principles and practices of the Canadian Dam Association (CDA) Dam Safety Guidelines (2007). Gouverneur Dam is classified as High Consequence due to the potential for loss of life and economic losses that are possible in the event of failure. The classification for the Braddock Dam is also High Consequence due to flood damage that would result in the Town of Hodgeville and to rural properties in the event of failure. As such, CDA Guidelines require the monitoring efforts meet industry standards to ensure the continued safety of the public and water storage operations. 2013 Dam Safety Reviews also identified the need to modernize the instrumentation and monitoring program to meet these standards.

For both the Gouverneur and Braddock Dams, AAFC requires a full geotechnical review. The review shall include drilling to obtain samples for testing in order to complete stability analysis at both sites. The review shall also include an assessment of the geotechnical instrumentation requirements with recommendations for the instrumentation and monitoring programs that can be implemented as part of the drilling program at both sites.

3.0 INTERPRETATION

In the Request for proposal "RFP",

- 3.1 "Canada", "Crown", "Her Majesty", "the Government" or "Agriculture and Agri-Food Canada" or "AAFC" means Her Majesty the Queen in right of Canada, as represented by the Minister of Agriculture and Agri-Food;
- 3.2 "Contract" or "Resulting Contract" means the written agreement between Agriculture and Agri-Food Canada and a contractor, comprising the General Conditions (set out in Appendix A of this RFP) and any supplemental general conditions specified in this RFP and every other document specified or referred to in any of them as forming part of the Contract, all as amended by agreement of the Parties from time to time;
- 3.3 "Contracting Authority or authorized representative" means the AAFC official, identified in Part 3, Article 5.0 of this RFP, responsible for the management of the Contract. Any changes to the Contract must be authorized in writing by the Contracting Authority. The Contractor is not to perform Work in excess of or outside the scope of the Contract

based on verbal or written requests or instructions from any government personnel other than the aforementioned AAFC official;

- 3.4 "Contractor", means the person or entity whose name appears on the signature page of the Contract and who is to supply goods or services to Canada under the Contract;
- 3.5 "Minister" means the Minister of Agriculture and Agri-Food or anyone authorized to act on his/her behalf;
- 3.6 "Project Authority or authorized representative" means the AAFC official, identified in Part 3, Article 6.0 of this RFP, responsible for all matters concerning a) the technical content of the Work under the Contract; b) any proposed changes to the scope of the Work, but any resulting change can only be confirmed by a Contract amendment issued by the Contracting Authority; c) inspection and acceptance of all Work performed as detailed in the Statement of Work, and; review and inspection of all invoices submitted;
- 3.7 "Proposal" means an offer, submitted in response to a request from a Contracting Authority, that constitutes a solution to the problem, requirement or objective in the request;
- 3.8. "Bidder" means a person or entity submitting a Proposal in response to this RFP;
- 3.9 "Work" means the whole of the activities, services, materials, equipment, software, matters and things required to be done, delivered or performed by the Contractor in accordance with the terms of this RFP.

PART 1: BIDDER INSTRUCTIONS, INFORMATION AND CONDITIONS

1.0 CONTRACTUAL CAPACITY

1.1 The Bidder must have the legal capacity to enter into legally binding contracts. If the Bidder is a sole proprietorship, a partnership or a corporate body, the Bidder should provide a statement indicating the laws under which it is registered or incorporated together with the registered or corporate name and place of business and the country where the controlling interest/ownership of the organization is located as per Appendix E of this RFP.

2.0 ACCEPTANCE OF TERMS AND CONDITIONS

- 2.1 Agriculture and Agri-Food Canada will <u>only</u> consider Proposals which accept Agriculture and Agri-Food Canada's terms and conditions.
- 2.2 The General Conditions attached in Appendix A and those set out in Part 3 of this RFP shall form part of any Resulting Contract.

3.0 INCURRING COST

- 3.1 The cost to prepare the Proposal will <u>not</u> be reimbursed by Agriculture and Agri-Food Canada.
- 3.2 No cost incurred before receipt of a signed Contract or specified written authorization from the Contracting Authority can be charged to any Resulting Contract.

4.0 ENQUIRIES - SOLICITATION STAGE

- 4.1 All enquiries or issues concerning this solicitation must be submitted in writing to the Contracting Authority named on the cover page of the RFP. It is the responsibility of the Bidder to obtain clarification of the requirements contained herein, if necessary prior to submitting a proposal.
- 4.2 Enquiries and issues must be received by the Contracting Authority no later than (ten)
 (10) calendar days prior to the solicitation closing date specified herein to allow sufficient time to provide a response. Enquiries or issues received after that time may not be able to be answered prior to the solicitation closing date.
- 4.3 To ensure consistency and quality of information provided to Bidders, the Contracting Authority will provide, simultaneously to all Bidders any information with respect to **significant** enquiries received and the replies to such enquiries without revealing the sources of the enquiries.
- 4.4 All enquiries and other communications with government officials throughout the solicitation period are to be directed ONLY to the Contracting Authority named below. Noncompliance with this condition during the proposal solicitation period may (for that reason alone) result in disqualification of a Proposal.
- 4.5 Meetings will not be held with individual bidders prior to the closing date/time of this RFP, unless otherwise specified.

4.6 Bidders shall not place any conditions or make any assumptions that attempt to limit or otherwise modify the scope of Work pursuant to the Statement of Work (Appendix B)

5.0 RIGHTS OF CANADA

- 5.1 Canada reserves the right to:
 - 1. Accept any Proposal in whole or in part, without prior negotiation;
 - 2. Reject any or all Proposals received in response to this RFP;
 - 3. Cancel and/or re-issue this RFP at any time;
 - 4. Ask the Bidder to substantiate any claim made in the Proposal;
 - 5. Enter into negotiations with one or more Bidders on any or all aspects of their Proposals;
 - 6. Award one or more Contracts;
 - 7. Retain all Proposals submitted in response to this RFP.

6.0 SUBSTANTIATION OF PROFESSIONAL SERVICES RATES

- 6.1 In Canada's experience, bidders will from time to time propose prices at the time of bidding that they later refuse to honour, on the basis that these prices do not allow them to recover their own costs and/or make a profit. When evaluating the prices for professional services bid, Canada may, but will have no obligation to, require price support for any prices proposed. Examples of price support that Canada would consider satisfactory include:
 - documentation (such as billing records) that shows that the Bidder has recently provided and invoiced another customer (with whom the Bidder deals at arm's length) for services similar to the services that would be provided under a resulting contract, and the fees charged are equal to or less than the price offered to Canada (to protect the privacy of the customer, the Bidder may black out the customer's name and personal information on the invoice submitted to Canada);
 - 2. a signed contract between the Bidder and an individual qualified (based on the qualifications described in this bid solicitation) to provide services under a resulting contract where the amount payable under that contract by the Bidder to the resource is equal to or less than the price bid;
 - 3. a signed contract with a subcontractor who will perform the work under any resulting contract, which provides that the required services will be provided at a price that is equal to or less than the price bid; or
 - 4. details regarding the salary paid to and benefits provided to the individuals employed by the Bidder to provide services, where the amount of compensation, when converted to a per diem or hourly rate (as applicable), is equal to or less than the rate bid for that resource category.

Once Canada requests substantiation of the prices bid, it is the sole responsibility of the Bidder to submit information (either the information described in the examples above, or other information that demonstrates that it will be able to recover its own costs based on the prices it has proposed) that will allow Canada to determine whether it can rely, with confidence, on the Bidder's ability to provide the required services at the prices bid, while, at a minimum, recovering its own costs. Where Canada determines that the information provided by the Bidder does not demonstrate the Bidder's ability to recover

its own costs in providing the prices bid, Canada may, at their sole discretion declare the bid non-compliant.

7.0 MANDATORY CLAUSES

7.1 Where the words **"must"**, **"shall" or "will"** appear in this RFP, the clause is to be considered as a mandatory requirement.

8.0 DEBRIEFING

8.1 After contract award, bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within the timeframe specified in the contract award notice. The debriefing may be in writing, by telephone or in person at the discretion of the Contracting Authority.

9.0 OFFICE OF THE PROCUREMENT OMBUDSMAN

If you have issues or concerns regarding the solicitation, you have the option of raising them with the department or with the Office of the Procurement Ombudsman (OPO). The Office of the Procurement Ombudsman was established by the Government of Canada to provide an independent avenue for suppliers to raise complaints regarding the award of contracts under \$25,000 for goods and under \$100,000 for services. PART 2: PROPOSAL PREPARATION INSTRUCTIONS & EVALUATION PROCEDURES

1.0 APPLICABLE LAWS

- 1.1 The Contract shall be interpreted and governed, and the relations between the parties, determined by the laws in force in the Province of Saskatchewan.
- 1.2 In their bid submission, bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their proposal, by deleting the Canadian province specified in the previous paragraph and inserting the Canadian province or territory of their choice. If no change is made, the bidder acknowledges the applicable law specified is acceptable to the Bidder.

2.0 SUBMISSION OF PROPOSAL

2.1 Proposals must be submitted in hard copy as described in Article 3.0.

Due to the nature of this RFP electronic transmission of proposal by such means as electronic mail or facsimile to the Department of Agriculture and Agri-Food is not considered to be practical and therefore will not be accepted.

- 2.2 The proposal **MUST** be delivered to and received by the Contracting Authority named on the cover page of the RFP no later than Tuesday July 21, 2015 at 2:00 pm CST. The outside of the envelope containing the proposal should include the RFP number found on the cover page of the RFP.
- 2.4 The onus for submitting proposals on time at the specified location rests with the Bidder. It is the Bidder's responsibility to ensure correct delivery of their proposal to the Contracting Authority.
- 2.5 The Bidders are advised that, due to security measures for building visitors, arrangements should be made in advance with the Contracting Authority for any planned in-person delivery of a proposal. Any planned **in-person delivery of proposal must be between 8:00 a.m. and 2:00 p.m. Monday through Friday** except on Government holidays and weekends. Failure to do so may result in late receipt of a proposal.
- 2.6 Proposals submitted in response to this RFP will not be returned.

3.0 PROPOSAL PREPARATION INSTRUCTIONS

3.1 The proposal **should** be structured in **THREE SEPARATELY BOUND parts** as indicated below:

Section 1	Technical Proposal (with no reference to price)	1 original hard copy and 1 electronic copy on CD or USB
Section 2	Financial Proposal	1 original hard copy and 1 electronic copy on CD or USB
Section 3	Certifications	1 original hard copy and 1 electronic copy on CD or USB

If there is a discrepancy between the wording of the soft copy and the hard copy, the wording of the soft copy will have priority over the wording of the hard copy.

3.2 The Bidder may **submit a proposal in either official language**.

3.3 Each copy of the proposal is to include the Bidder's legal entity name, the name of the Bidder's contact, address, telephone number, facsimile number, email address and the RFP Number.

4.0 PREPARATION OF TECHNICAL PROPOSAL (Section 1)

4.1 In the Technical Proposal, the Bidder should demonstrate its understanding of the requirements of the **Statement of Work Appendix "B"**, as well as demonstrate how the Bidder will meet the requirements of the **Evaluation Procedures and Criteria Appendix "D"**.

4.2 Security Requirements

5.0 PREPARATION OF FINANCIAL PROPOSAL (Section 2)

In the Financial Proposal, the Bidder shall provide a firm all inclusive price to provide the services requested in accordance with the Statement of Work **Appendix B**.

The requirements of the Financial Proposal are detailed in Appendix D, Evaluations Procedures and Criteria.

Prices shall not appear in any area of the proposal except in the Financial Proposal.

6.0 CERTIFICATION REQUIREMENTS

In order to be awarded a contract, the certifications attached **in Appendix "E"** will be required. The certifications should be submitted with the proposal. Canada may declare a bid non-responsive if the certifications are not submitted or completed as required. Where Canada intends to reject a proposal pursuant to this paragraph, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time frame period will render the proposal non-responsive.

Compliance with the certifications the Bidder provides to Canada is subject to verification by Canada. The Contracting Authority shall have the right to ask for additional information to verify that the Bidder is compliant with the applicable certifications before and after award of a contract. Any certification made by the Bidder that is determined to be untrue, whether made knowingly or unknowingly, or any failure to comply with the certifications or comply with the request of the Contracting Authority for additional information, will render the bid non-responsive.

7.0 EVALUATION PROCEDURES

- 7.1 Proposals will be evaluated in accordance with the Evaluation Procedures and Criteria specified **in Appendix D**. Proposals received will be compared separately against the evaluation criteria identified therein for the total requirement described in this RFP and in conjunction with the accompanying Statement of **Work (Appendix B)**.
- 7.2 An evaluation team composed of representatives of the Department of Agriculture and Agri-Food Canada will evaluate the Proposals on behalf of Canada.
- 7.3 The evaluation team reserves the right, but is not obligated, to perform any of the following tasks:
 - a) seek clarification or verification from bidders regarding any or all information provided by them with respect to the bid solicitation;
 - b) contact any or all references supplied by bidders to verify and validate any information submitted by them;
 - c) request, before award of any contract, specific information with respect to bidders' legal status;
 - d) verify any information provided by bidders through independent research, use of any government resources or by contacting third parties;
 - e) interview, at the sole costs of bidders, any bidder and/or any or all of the resources proposed by bidders to fulfill the requirement of the bid solicitation.

8.0 REQUESTS FOR PROPOSAL AMENDMENT(S)

8.1 Any modifications to this RFP will be made through an amendment which will be posted publicly via GETS.

PART 3: RESULTING CONTRACT TERMS AND CONDITIONS

Upon a Contract being awarded pursuant to the following Terms and Conditions shall form part of the Resulting Contract:

1.0 GENERAL CONDITIONS

1.1 The General Conditions attached **in Appendix A** shall form part of any Resulting Contract.

2.0 REQUIREMENT

- 2.1 The contractor will provide the services identified in Appendix B, Statement of Work.
- 2.2 The Contractor shall maintain, for the duration of the Contract, a designated single point of contact, hereafter referred to as a Contractor Representative, dedicated to managing the Contract.

3.0 SECURITY REQUIREMENT There is no security associated with the work.

4.0 CONTRACT PERIOD

4.1 The Contract shall be from the date of contract award to February 5, 2016.

5.2 The Contracting Authority (or authorized representative) is responsible for the management of the Contract. Any changes to the Contract must be authorized in writing by the Contracting Authority. The Contractor is not to perform Work in excess of or outside the scope of the Contract based on verbal or written requests or instructions from any government personnel other than the aforementioned officer.

6.0 **PROJECT AUTHORITY**

 - Shall be established as the only recognized individual from the Contractor's organization to speak on behalf of the Contractor for purposes of Contract management;
 - 5. Monitor all resources that are providing services/deliverables in accordance with the Contract;
 - 6. Liaise with the Project Authority on all matters concerning technical aspects of the Work and performance of its resources; and
 - 7. Manage the transition of any potential resource(s) turnover during the period of the Work.

8.0 **PRIORITY OF DOCUMENTS**

9.0 BASIS FOR CANADA'S OWNERSHIP OF INTELLECTUAL PROPERTY

In this section of the RFP,

- 9.1 "Material" means anything that is created or developed by the Contractor as part of the Work under the Contract, and in which copyright subsists, but does not include computer programs and related software documentation.
- 9.2 Agriculture and Agri-Food Canada has determined that any intellectual property arising from the performance of the Work under the Contract will vest in Canada, on the following grounds:

Pursuant to 6.5 of the Treasury Board Policy on Title to Intellectual Property Arising under Crown Procurement Contracts, Canada has opted to own the intellectual property rights in any Material subject to copyright that is created or developed as part of the Work, with the exception of computer software or any documentation pertaining to such software.

10.0 REPLACEMENT OF PERSONNEL

- 10.1. The Contractor will provide the services of the personnel named in the Contractor's Proposal to perform the Work, unless the Contractor is unable to do so for reasons which are beyond its control.
- 10.2 Should the Contractor at any time be unable to provide their services, the Contractor will contact the Project Authority immediately. In such case, the Contractor is responsible to provide replacement Contractor or personnel who shall be of similar skills and experience as stated in **the Appendix D, Evaluation Procedures and Criteria**.
- 10.3 The Contractor shall propose replacement personnel for the Project Authorities review within 5 working days (resume and references). The Contractor shall submit, in writing, to the Project Authority the reasons for the removal of personnel from the Work; the name of the proposed replacement person(s); and the qualifications and experience of the proposed replacement person(s). The Project Authority reserves the right to interview any personnel proposed to be assigned to the Work.
- 10.4 Personnel assigned pursuant to the requirements will be capable of performing the Work at a reasonable level of competence. Should any assigned personnel be deemed unsuitable by the Project Authority the Contractor shall provide an immediate replacement of suitable ability that is acceptable to the Project Authority.
- 10.5 The Contractor shall supply competent back-up personnel so that in the event of unforeseen sickness, accident, or any cause which renders a specific individual unavailable, such individuals can be replaced within five (5) working days by a person of like abilities and qualifications.
- 10.6 The resources assigned for the Contract will be measured regularly for quality of services rendered. The measurement will be based on the quality and timeliness of the

deliverables specified in the Statement of Work. In the event that quality and deliverables are not produced as and when requested, in any given month, the Crown has the right to request that the Contractor replace the assigned resources immediately, in accordance with Contract clauses included in or referenced in the RFP #4547:928-7I4-0-S1-13.

10.7 In no event shall the Contractor allow performance of the Work by unauthorized and/or unqualified personnel, whether initially named resources or replacement personnel. In addition, acceptance of any replacements by the Project Authority shall not relieve the Contractor from responsibility for failure to meet the requirements of the Contract.

11.0 ACCESS TO GOVERNMENT FACILITIES/EQUIPMENT

12.0 DAMAGE TO OR LOSS OF CROWN PROPERTY

12.1 The Contractor shall reimburse Canada any cost or expenses due to the damage to or loss of Crown-owned property resulting from the Contract or the carrying out thereof, or shall, upon reasonable notice, promptly repair such damage or substitute such loss to Canada's satisfaction.

13.0 BASIS OF PAYMENT

13.2 Firm Lot Price:

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.

14.0 METHOD OF PAYMENT

A - PROJECT DESCRIPTION AND ENGINEERING SERVICES REQUIRED

1. INTRODUCTION

Corporate Management Branch of Agriculture and Agri-Food Canada (AAFC) is the owner/operator of infrastructure and land associated with twenty nine (29) water storage projects in southern Saskatchewan. These works were among the many built between 1935 and 1960 as part of PFRA's legislated mandate to help stabilize and contribute to the economic security of the drought prone regions of western Canada. Gouverneur Dam is located near the Towns of Ponteix and Cadillac, Saskatchewan, and provides irrigation, stock watering, recreation, flood protection, rural domestic and municipal water supplies for the area. Braddock Dam is located near the Village of Braddock, Saskatchewan and provides water for irrigation, stock watering, stock watering and recreation.

AAFC manages these dams in accordance with the principles and practices of the Canadian Dam Association (CDA) Dam Safety Guidelines (2007). Gouverneur Dam is classified as High Consequence due to the potential for loss of life and economic losses that are possible in the event of failure. The classification for the Braddock Dam is also High Consequence due to flood damage that would result in the Town of Hodgeville and to rural properties in the event of failure. As such, CDA Guidelines require the monitoring efforts meet industry standards to ensure the continued safety of the public and water storage operations. Dam Safety Reviews undertaken in 2013 also identified the need to modernize the instrumentation and monitoring program to meet these standards.

For both the Gouverneur and Braddock Dams, AAFC requires a full geotechnical review. The review shall include drilling to obtain samples for testing in order to complete stability analysis at both sites. The review shall also include an assessment of the geotechnical instrumentation requirements with recommendations for the instrumentation and monitoring programs that can be implemented as part of the drilling program at both sites.

2. BACKGROUND ON GOUVERNEUR DAM

Gouverneur Dam is one of twenty nine (29) water storage projects that AAFC owns and operates in Southern Saskatchewan. The project is located along the Notukeu Creek in the NW ¼ of section 25 and SW ¼ of section 36 Twp 9 Rge 13 W3M, 6 kilometers west of Ponteix. The project was constructed by PFRA in 1952.

Components of the dam consist of a 14.10 meter high, 320 meter long zoned earthen embankment with a semi pervious core, cut-off trench, an impervious upstream clay blanket, a pervious material downstream slope and a downstream toe tile drain. The maximum crest width of the embankment is 5.48 metres, with a bedding gravel and riprap armoured 3:1 upstream slope (with a 3.0 meter wide lower berm) and a 2:1 well grassed downstream slope (transitions to 3:1). The reservoir storage capacity at Full Supply Level is 7934 dam3. The project also includes an un-gated concrete chute spillway with an ogee weir, a gated riparian outlet structure and earth cut emergency spillway.

Gouverneur Dam is located in the Notukeu Creek Valley. The creek occupies a partially filled bedrock channel (stream trench) which was originally a tributary to the preglacial Gravelbourg

Valley. Surficial deposits filling the trench consist of till (locally absent) with a thin blanket deposited in the form of low relief ground moraine. As such the topography directly reflects the original bedrock surface, having a vertical relief of 15 to 30 meters and a width of 400m in the vicinity of the dam site. The underlying bedrock deposits are composed of dark grey, highly plastic clay-shales of the Upper Cretaceous Bearpaw Formation. These shales exibit behavior lying on the boundary between rock and soil.

The foundation geology underlying the embankment consists of the highly plastic impervious Bearpaw shale, overlain by a pervious blanket, 1.5 to 3.6 meters thick, composed of medium to coarse grained alluvial sand. The west abutment consists of Bearpaw shale overlain by till (no contact exposed), while the east abutment is predominantly Bearpaw shale. The reservoir banks expose variable thicknesses of till underlain by the Bearpaw shale.

At present, geotechnical instrumentation at Gouverneur Dam consists of 5 standpipe piezometers in the embankment. These were installed shortly after the original construction in 1952 and remain operable, although condition is questionable. These instruments require manual data collection which is limited in frequency due to time, resources and relative isolation of the site. AAFC intends to have the geotechnical instrumentation and monitoring program meet industry standards for a dam with a "High" consequence classification.

Additional information is contained in the Supplemental Information.

BACKGROUND ON BRADDOCK DAM

Braddock Dam is another of the 29 water storage projects AAFC owns and operates in southern Saskatchewan. It is located along the Wiwa Creek near the Village of Braddock in the NE ¼ of section 19 Twp 13 Rge 10 W3M, 40 kilometers southeast of Swift Current, Saskatchewan. The project was constructed by PFRA in 1951.

Components of the dam consist of a 12.2 meter high, 213 meter long zoned earthen embankment with a cutoff trench and a downstream berm with a filter blanket. The embankment has a maximum crest width of 6.1 meters, a bedding gravel and riprap armoured 3:1 upstream slope (with 3.0 meter wide lower berm) and a well grassed 3:1 downstream slope (with a 4.5 meter wide lower toe berm). The downstream filter blanket underlays approximately two thirds of the embankment. The reservoir storage capacity is 3784 dam3 at Full Supply Level. The project also includes an un-gated concrete chute spillway, a gated riparian outlet structure, and earth cut emergency spillway.

Braddock Dam is located in the Wiwa Creek Valley within the Cypress Hills, which are a glaciated plateau. The dam is located on a dissected till plain along the flanks of these hills. The general topography reflects the bedrock surface except at areas of infilled bedrock valleys or meltwater channels such as Wiwa Creek.

The foundation consists of 4 to 5 meters of sand and gravel underlain by an unknown depth of highly plastic clay and shale bedrock from the Bearpaw formation. These shales exhibit behavior that lies on the boundary between rock and soil. Both abutments consist of 7 meters of sandy, silty clay till of medium plasticity. The shale bedrock is not encountered in these areas.

At present, there is no geotechnical instrumentation at Braddock Dam. AAFC intends to implement a geotechnical instrumentation and monitoring program which meets industry standards for a dam with a "High" consequence classification.

Additional information is contained in the Supplemental Information.

3. SCOPE

The purpose of this solicitation is to obtain the services of an engineering consultant to:

- 1. Collect all information necessary to complete a stability analysis on the two dams included in this study.
- 2. Complete a full stability analysis on the two dams included in this study in accordance with the Canadian Dam Association Dam Safety Guidelines (2007).
- 3. Recommend a long term instrumentation monitoring plan.

4. ENGINEERING SERVICES REQUIRED

4.1 INFORMATION COLLECTION

For both the Gouverneur and Braddock Dams, the collection of information shall include but is not limited to: review of existing drill logs and available reports/records; drilling investigations where necessary to undertake in situ testing, geophysical logging and sampling; laboratory testing of collected samples to determine specific properties required for the stability modelling; and installation of instrumentation (with limited data collection) as necessary to determine pore pressures.

AAFC's expects, for bidding purposes, that three boreholes be drilled at each dam site with vibrating wire piezometers and data loggers permanently installed. All instrumentation installed shall be consistent with practices adopted by AAFC and, as such, be manufactured by Durham Geo Slope Indicator. Installations require adequate protection from livestock and wildlife with a steel fence type enclosure. AAFC is to be consulted regarding any proposed installations.

It is the consultant's responsibility to become familiar with the site and utilize appropriate equipment and installation methods for the site conditions. Supplemental information includes site layout plans and geotechnical records.

4.2 STABILITY ANALYSIS

The completion of a full stability analysis for the Gouverneur and Braddock Dams shall be in accordance with the Canadian Dam Association Dam Safety Guidelines (2007) and shall detail the determination of factors of safety with respect to embankment slope stability and the pore pressure threshold values. The analysis shall consider the static, seepage, drawdown, surcharge and seismic loading conditions at each site. The analysis shall include an assessment of the seepage controls and erosion resistance currently in place.

If the analysis determines that the embankment stability does not meet an appropriate standard of care in any way, the consultant shall provide feasibility level recommendations for further analysis or remedial measures.

4.3 MONITORING PLAN

Recommendations for implementing a long term monitoring plan should include items such as monitoring schedules, operation and maintenance procedures, data analysis methods/procedures and software/hardware upgrades for future consideration.

4.4 FINAL REPORT

For both the Gouverneur and Braddock Dams, the final report(s) will detail the geotechnical review and include all documentation and information necessary to successfully operate the instrumentation such as:

- drill logs detailing borehole data and VW piezometer placement,
- final site plan detailing locations,
- stability analysis and piezometer threshold limits,
- instrumentation manuals,
- VW calibration factors,
- software manual, and
- operation and maintenance procedures (including troubleshooting).

A separate report is required for each dam.

5. PERSONNEL

The Consultant shall have a qualified registered professional engineer responsible for the technical content, findings and recommendations of this study and report. The Consultant shall identify each member of their project team, as well as their respective roles and responsibilities and append resumes. The Consultant shall have similar recent experience and shall provide a list of recent projects of a similar nature. The Consultant shall meet the requirement for professional registration within Saskatchewan.

- 7. DURATION/PERIOD OF CONTRACT: The contract period will endure until February 5, 2016.

3. Definition of joint venture

A joint venture is an association of two or more parties who combine their money, property, knowledge, skills, time or other resources in a joint business enterprise agreeing to share the profits and the losses and each having some degree of control over the enterprise. Joint ventures may be carried on in a variety of legal forms divided into three categories:

- (a) The incorporated joint venture;
- (b) The partnership venture;
- (c) The contractual joint venture where the parties combine their resources in the furtherance of a single business enterprise without actual partnership or corporate designation.
- 4. The joint venture team arrangement is to be distinguished from other types of Contractor arrangements, such as:
 - (a) Prime Contractor, in which, for example, the purchasing agency contracts directly with a Contractor (prime) who acts as the system assembler and integrator, with major components, assemblies and subsystems normally subcontracted;
 - (b) Associated Contractor, in which for example, the purchasing agency contracts directly with each of the major component suppliers and performs the integration tasks or awards a separate contract for this purpose.
- 5. If the Contract is awarded to an unincorporated joint venture, all members of the joint venture shall be jointly and severally responsible for the performance of the Contract.
