Amendment 001 is being raised to answer questions from a potential bidder:

Question

1. Will you provide and guarantee the minimum amount of bathymetric survey work per year (i.e., the dollar value/year) that will be issued to each of the individual companies on the approved Supply Arrangement List or at least the minimum amount of bathymetric survey work per year (i.e., the dollar value/year) that will be outsourced to approved SA holders.

Answer 1

There is no guarantee amount of bathymetric survey work per year (i.e., dollar value/year) that will be issued to each individual companies that qualify on the Supply Arrangement Holder List.

Please note:

Supply Arrangements

A supply arrangement (SA) is a non-binding arrangement between Canada and a pre-qualified supplier that allows departments and agencies to award contracts and solicit bids from a pool of pre-qualified suppliers for specific requirements within the scope of the SA.

An SA is not a contract for the provision of the goods and services described in it and neither party is legally bound, as a result of signing a supply arrangement alone. The intent of a supply arrangement is to establish a framework to permit expeditious processing of individual bid solicitations, which result in legally binding contracts for the goods and services described in those bid solicitations.

An SA may be used when:

- the overall requirement cannot be clearly defined at the outset and it is proposed to establish a pool of screened suppliers from which clients and PWGSC solicit bids for individual requirements;

- a commodity is procured on a regular basis (goods or services);

- a standing offer is not suitable, due to variables in resulting call-ups (e.g. varying methods/basis of payment, or the statement of work or commodity cannot be adequately defined in advance);

- a simplified solicitation, undertaken by users/clients, can be used to obtain competitive bids from the pre-qualified suppliers;

- selection will be based on best value, as described in the SA and the subsequent solicitation; and

it is more efficient for PWGSC to operate as the provider of the framework on behalf of other users/clients and not as the contracting authority.

Question

2. On Page 17 of the Request for Supply Arrangement (RFSA), Item 1 Bid Solicitation Requirements, Sub-item 2.1, it states that *"For all requirements up to an estimated value of \$400,000.00 (HST included), the Identified user must issue a "Task Requisition" to a subset of the (SA) Holders"*. On same page, Item 3.2 A), it states *"Work estimated at less than \$400,000.00 (HSTI): - these requirements will be sent to all SA holders on the supply arrangement by the identified users listed above"*. These two statements are contradictory. Will the "Task Requisition/Requirements be sent to a select subset or to all of the SA holders?

Answer

As per 1. Bid Solicitation Requirements :

A). **Work estimated at less than \$400,000.00 (HSTI):**

- these requirements will be sent to all SA holders on the supply arrangement by the identified users listed above.

B). **Work estimated over \$400,000.00 (HSTI) :**

- these requirements will be sent to all SA holders on the supply arrangement by PWGSC directly with the above identified users acting solely as the technical authority.

Requirements will be sent directly to supply arrangement holders in the form of a Bid Solicitation - Request for Quotation (RFQ. Each RFQ will contain specific detail on the services required, specific location of the requirement, required certification, and instructions to submit quotation and a basis of payment.
