This amendment is raised to answer questions from bidders.

**Q2** - Will my security clearance and insurance coverage, obtained for last tender, be applicable for this new one? Or do I have to obtain new documents?

**A2** - I cannot tell you whether your documents are applicable or not. The security clearance and insurance must meet the requirements set out in this solicitation and must be maintained throughout the duration of the SO.

**Q3** - In section A1.1 Mandatory Technical Criteria MTI, could you please clarify what the following statement is referring to "a minimum of one project per year must be submitted"? Does this mean that the proposal requires the Offeror to submit proof of one ergonomic assessment completed per year and do you want a sample report for each or does this mean you want the Offeror to identify a project they have completed each year besides ergonomic assessments (e.g. Presentation?)

**A3** - The Offeror must provide the information as stated in MT1 for a minimum of one (1) ergonomic assessment per year for the past five (5) years. As stated, references may be contacted to verify the work performed.

**Q4** - The closing date for this proposal is July 3, 2015. Is it possible to get an extension?

**A4** - The closing date of this RFSO has been extended to July 16, 2015.

**Q5** - I just wanted to confirm that this submission is a whole new submission; as the title does say "NMSO Renewal" and there have been several renewals/extensions in the past that did not require resubmission.

**A5** - This is a new Request for Standing Offer (RFSO). It is a Renewal of the Existing National Master Standing Offer (NMSO) and replaces Solicitation E60ZQ-140001/A. As stated in this RFSO, "This solicitation cancels and supersedes previous solicitation number E60ZQ-140001/A dated November 3, 2014 with a closing of November 24, 2014 at 2:00 p.m." The extensions you have seen have been for the existing NMSO (E60ZH-100002/XXX/ZH).

**Q6** - Will the current NMSO be extended past July 2nd, 2015 or will you be going with the renewal one past July 2nd, 2015?

**A6** - The current NMSO (E60ZH-100002/XXX/ZH) will be extended to August 31, 2015.

**Q7** - I would like to find out if we could apply for your Ergonomics Assessment / RFP. We are not currently a service provider for your Department
