LOI amendment No. 008 is raised to (1) answer questions from the industry and (2) make modifications to the LOI, all as follows:

QUESTIONS AND ANSWERS

Question #4

Who will be attending the One on One sessions from CBSA and PWGSC? Not specifically the names of the individuals who will be attending but more their roles with CBSA and their titles and levels. We want to ensure that we have the proper level of presenters for the One on One session and knowing who will be attending is fundamental to achieving that goal.

Answer #4:

Attendees from the Government of Canada will include CBSA Leadership, Project Leadership, PWGSC Contracting Team and the Fairness Monitor. The CBSA Leadership will be led by either the Associate Vice President, ISTB or the Director General, CARM Project, ISTB, depending on schedules.

Question #5

We noticed that the one-on-one sessions are scheduled for the week of July 6th to 10th and not sure if that is still the case however we would like to suggest that if possible could they be spread over two weeks (mid-week to mid-week) as PWGSC are also hosting 3 full days of industry sessions for e-Procurement on July 7th, 8th and 9th and a lot of the vendors on CARM will also be involved in e-Procurement.

Answer #5:

Per the modification done to the Annex G of the LOI (see below), the one-on-one meetings will be extended over two weeks, from July 6-17th.

Question #6

It states "Number of people to attend the One-on-One meeting (to a maximum of 5 per interested supplier)", we were just wondering if there will be a teleconference number supplied like industry day?

Answer #6:

Suppliers may use a teleconference to allow supporting personnel to join via phone, however the total number of supplier attendees is not to exceed 5 including both in person and remote attendees. The primary speaker(s) must attend in person. Canada will provide a speaker phone in the room and the supplier will be responsible for setting up the teleconference and must provide the Contracting Authority with a local or toll-free number to dial at least 2 days in advance. All remote participants are to be on separate lines without the use of speaker phones and recording of the meeting is not permitted. Webex or video conferencing will not be allowed. All participants must be identified and the Terms of

Engagement, if not already done, must be signed by each participant or by a supplier representative on behalf of all the supplier participants.

Question #7
