For example, line 1 Bacon 16-18: the format is 1 X 5Kg - the approx. qty is 4000 - the U of M is KG. Is the approx. qty of 4000 referring to boxes of 1 X 5Kg = 20,000 KG or 4000 KG = 800 X 5KG boxes?
