This amendment is raised to answer a question from industry during the above-mentioned solicitation:

Questions 1

Many Manufacturers only publish MSRP in USD\$ and care not available in Canadian dollars, will PWGSC accept clearly indicated MSRPs in USD\$ and allow users to convert using current exchange rate at time of call-up?

Response 1

Manufacturer Letters and Manufacturer's Suggested Retail Price (MSRP) Lists

If discrepancies in the letters and/or MSRP price lists exist, PWGSC has the right to reject all or some of the Offeror submissions.

Section II: Financial Offer

The Offerors must submit their financial offer in accordance with the Basis of Payment. The Offeror must submit firm percentage discounts based on manufacturer suggested retail pricing in Canadian dollars, DDP Incoterms® 2000 for the various delivery destinations within any (1) of the six regions of Canada defined in Section 3.0 of Annex A excluding Applicable Taxes but including all other costs such as, but not limited to, fees of all sorts, customs duties, excise tax and freight charges to the point(s) of delivery. The discounts offered are firm for the period of the resulting Standing Offers.

To summarize: all percentage discounts offered must be based on Canadian dollar manufacturer price lists that are identical across all Offerors of a particular manufacturer. The Canadian currency price lists supplied by each Offeror of a particular manufacturer must be sourced from only one source, the manufacturer or a single authorized distributor. Offerors must not be converting price lists from one currency to another on their own as they risk submitting a price list different from other Offerors of the same manufacturer, which could lead to their Offer being rejected. Users are prohibited from converting quoted products prices from one currency to another at the time of call-up because **"1.3 Exchange Rate Fluctuation:** Exchange rate fluctuation protection is not offered for this requirement. Any request for exchange rate fluctuation protection will not be considered and will render the offer non-compliant."

Without identical price lists, a fair and accurate evaluation across the dealers of a particular manufacturer cannot be done.

All other terms and conditions remain unchanged.
