#### **2. Changes from the previous solicitation**

- a. Zone 2 coverage limited to Lower mainland up to Hope. All other areas are optional.
- b. Possible large shipping need in Prince Rupert for DND ships. Bidders to identify whether or not they can cover this location. Suppliers may be eligible for extra shipping cost to non mandatory areas/locations.
- c. Minor changes to evaluation method. Suppliers are to submit new pricing for all items on each category per each refresh cycle. Each category will be evaluated per refresh cycle and award will be allocated for each refresh period. Suppliers will be notified of new list.

#### **3. Splittable products**

- a. Bidder may put additional descriptions in comment or description box.
- b. It was also noted that the unlocked spreadsheet is provided so bidders may add columns and/or rows. It was requested to note newly added row if any to help ease the evaluation process.

#### **4. Conversion of Units**

- a. Conversion of units from Pound to Kg or vice versa or others.
- b. Directed bidders' attention to the evaluation sample spreadsheet which already has many of the functionality built in. Bidders may bid using their own unit of measure and if necessary, will be converted to metric or to imperial.

#### **5. General updates related to Government Food purchasing**

- a. If supplier wishes to add representatives of various locations to cover various areas and still wish to adhere to the SOA pricing, it will be up to the SOA offeror to identify each representative(s).
