## ARCHITECTURAL SPECIFICATIONS

### ADD 01 11 55 General Instruction

#### 1.11 CONTRACTOR USE OF PREMISES

- .16 Contractor responsible for installing and removing protection measures during delivery and movement of materials and equipment. Contractor will be responsible for repairing any damage to finishes in the public corridors caused by construction activities, this includes replacement if found necessary by the Departmental Representative.

**2.1      MATERIALS – SHEET FLOORING**

Replace Vinyl Sheet with the following:

- .1      Linoleum sheet flooring: ASTM F2034, Type 1, homogenous, composed of natural ingredients which are mixed and calendered onto a jute backing:
  - .1      Pattern: marbleized.
  - .2      Total Thickness: 2.5 mm.
  - .3      Sheet Width: 2000 mm.
  - .4      Wear Layer: UV cured, double layer.
  - .5      Maintenance: No wax, no polish, no finish for the life of the product.
  - .6      Colour: to be selected from manufacturers standard colour range.
