Questions and Answers

1. Page 41, Section 3 point 8

In Accordance with the "Guaranteed Transit Times" indicated in Annex "B"
Question I have is: where in Annex B are the desired transit times requirement.

ANSWER: see attached spreadsheet "Guaranteed Transit Times" in Basis of payment titled "GTT BoP"

2. Section 4.1.2.2

Any requests for increases in air fuel or security surcharges must upon request from the standing offer Authority, include price support.

Question: Can you specify what kind of price support would be acceptable in regards to fuel surcharge increases.

ANSWER: invoice, cost breakdown, receipts or any document or way bill etc

3. Page 24, point 4.1.2.2 SURCHARGES: Is our understanding correct that Fuel Surcharge and Security Surcharge are **not supposed to be included in the prices to be entered in Annex B ? If so, how do you want us to submit the corresponding charges and when?**

ANSWER: Yes, not supposed to be included in Annex B. Enter surcharges in attached spreadsheet called "Surcharge rate template"

4. Page 35, 7.5.2. Ancillary Charges: is our understanding correct that NavCan is **not supposed to be included in the prices to be entered in Annex B? If so, does the same apply for "screening fees" and "terminal charges" which might be charged by the airlines**

ANSWER: Yes, not supposed to be included in Annex B, however the NavCan charges should include screening fees and terminal charges

5. Page 48, point 2: All Risk In Transit Insurance: this clause states that "Government Property must be insured on replacement cost basis". As this cost might exceed the minimum requirement of CAD 250 per bag, please confirm whether it is correct that insurance costs are **not supposed to be included in the prices to be entered in Annex B. Where would you want insurance rates to be shown in the Offer?**

ANSWER: Yes, not supposed to be included in Annex B. Provide insurance certificate as stated in Annex C

6. Can you please clarify the following for us: Considering there is no value or contents declared at the time of shipping, in the case of a lost bag, can you please clarify the claim amount to be filed. Would it be a max of \$350.00/bag lost? Please confirm.

ANSWER: Please refer to 7.0 SERVICE FAILURES on page 43 – English RFSO and page 45 – French RFSO

7. On page 15, Section 4.1.2.1.3 it outlines that all prices submitted by the Offeror are inclusive of **all fees** and expenses for the period of the standing offer. We have interpreted this as when we submit rates in the Basis Of Payment (BOP) we are to present all in rate including any accessorial charges including fuel surcharge etc. Are we to include an all in rate excluding FSC and security fee?

ANSWER: No, BOP includes fixed rate and any other charges needs to be identified on the invoices as they fluctuate.

8. On page 24, Section 4.1.2.2 it outlines that Air fuel and security surcharges quoted in an offer are to be based on the air fuel and security surcharges effective May 31, 2015. Does this mean that we have to present a fixed FSC for the duration of the contract or request in writing a change if required?

ANSWER: No, the BOP is a fixed rate, and any other charges needs to be identified on the invoices as they fluctuate (same response as previous clause as they require same clarification).
