This amendment is raised:

2.19.2.1.6. The following overall dimensions shall be assumed for the MSVS Shelter (all variants):
2.19.2.1.6.2. MSVS Shelter sitting on the MSVS vehicle: 370.84 cm height; 243.84 cm width
Please confirm the maximum height for the vehicle boot is 370.84 cm. MSVS Shelter height is 96"(243.84cm) and the maximum height of the MSVS truck per the MSVS baseline specification is 63" (160.02cm) for a total of 159" (or 403.86 cm). Clarification required to ensure accurate

Response:

Appendix AA to Annex A, Volume 2, Para 2.19.2.1.6.2 & 2.19.3.6.2 are amended to read as follows:

" 2.19.2.1.6.2 MSVS Shelter sitting on the MSVS vehicle MilCOT Configuration D, 21' extended flatbed: 403.86 cm height; 243.84 cm width and
2.19.3.6.2 403.86 cm maximum height; by 243.84 cm maximum width. "

Question 380

Reference: HQSS Requirements Verification Matrix, Appendix AA to Annex A to Volume 2; Section 4.9. Semi-Rigid Flooring - Colour, page 141

4.9.1. The Semi-Rigid Flooring shall be colour 34094 (green 383) in accordance with US Federal Standard 595C or Technical Authority approved equivalent.

Please confirm that black colour flooring is also acceptable as per Serial Number 163 of Amendment 15 of the Draft RFP.

Graphite or Carbon is typically required in the floor structure resin to ensure ESD compliance, this will cause the floor to be dark in colour. Choosing a specific colour or adding a coating will increase cost or potentially render the floor noncompliant.

Response:

Confirmed, black colour flooring is acceptable.

Question 381

Amendment 006, Question 282 - The response to Question 282 confirms that all of the shelters will be rated and scored based on each shelter's specific snow load capabilities, as set forth in RFP Vol. 1, Appendix BA, Paragraphs 1.40.2.7.7.,8, and .9. However, the RVM (RFP Vol. 2, Appendix AA) states that the Pre-Contract Means Of Compliance for these requirements will be by Compliance Statement, and that Testing will not occur until Post-Contract. We believe this methodology precludes a fair and equal ("apples-to-apples") comparison between competing shelters because each shelter's snow load evaluation score will be based on each separate bidder's different internal engineering and/or testing methods, none of which will be performed on a common basis. The only reasonable and fair Pre-Contract Means to rate and score each shelter's snow load capability is to perform Pre-Contract Testing on every shelter, so that all shelters are tested and rated on the same basis. The current means of basing snow load rating scores on each bidder's varying internal engineering and/or testing methods will preclude a fair and equal comparison and scoring between different shelters. We request that the RFP be amended to include Pre-Contract snow-load testing on all shelters to be evaluated.

Response:

No change to the requirement. Canada has retained the service of a Third Party to participate and assist in Phase 2 of the Bid Evaluation - HQSS Performance Verification. To preserve the integrity, availability and project timeline, Canada does not intend to evaluate all shelters Pre-contract award. Snow load will be verified pre-contract award only on the Planning shelter since it is the most used shelter in the field.

Question 382

Amendment 006, Questions 287 and 297 - The responses to Question 287 and 297 confirm that each bidder is required to supply its own PPE and IECS. Please identify sources where the appropriate PPE and IECS may be purchased.

Response:

The bidder is responsible to identify sources where the appropriate PPE and IECS may be purchased.

Question 383

Amendment 006, Questions 289 and 299 - The responses to Questions 289 and 299 indicate that office furniture may be used in lieu of a ladder for shelter erection or dismantling. The RFP indicates that office furniture will be supplied by the Canadian Government. Please confirm that the office furniture to be supplied by the Canadian Government has a non-slip surface and other Health & Safety features necessary to allow this type of use in a safe and compliant manner.

Response:

No Government Supplied Material (GSM) will be provided under this project. No office furniture will be supplied by the Canadian Government during the verification testing pursuant to answers to Questions 289 and 299 pertaining to step ladder usage. Since step ladders are not allowed to be used during the testing, the bidder shall be responsible to provide a chair / table that have a non-slip surface and other health and safety features necessary to allow this type of use in a safe and compliant manner. The chair height is 450mm and the table 762 mm.

Question 384

Amendment 006, Question 307 - The response to Question 307 states that the soft flooring shall cover the entire area of semi-rigid flooring, but does not address the contour (i.e., "lip") requirement in RFP Vol. 2, Appendix AA, Paragraph 2.5.6. Please identify how much contour (i.e., lip) the soft flooring is required to have.

Response:

Please refer to answer provided for question 307. As a minimum, the soft flooring shall cover the entire area of semi-rigid flooring. There is no requirement to cover the contour (i.e., "lip") for the shelter.

Question 385

Amendment 006, Question 309 - The response to Question 309 refers to Vol. 2, Appendix AA for the dimensions of the Table and Chair. The referenced provisions only provide the dimensions of the legs themselves, which along with the weight are needed for floor load calculations, but does not provide the lay-out dimensions of the Table and Chair, which are needed for space and lay-out considerations. Is it possible to provide the lay-out dimensions (i.e., W x L x H) of the Table and Chair?

Response:

A six-foot table with two chairs would comprise a "normal work-space." With computer monitors and 95 percentile soldiers sitting at them, this workspace would be roughly around 762 mm high X 1828.8 mm long X 762 mm wide (or deep). For the chairs, soldiers are using a folding chair of 450 mm high.

Question #413:**Reference:****Clarifying VP R&D Commitments versus ITB Crediting for Academia IMS R&D Transactions**

As noted in the Value Proposition Guide, "To incentives bidders to partner with Canadian universities and colleges, additional points may be awarded based on the R&D that bidders and their major suppliers propose to undertake with accredited Canadian post-secondary institutions. Companies that turn to universities and colleges for support often contribute to more transformational technological advances with the potential for benefits to spill over to other firms and sectors of the economy. Industry-academic partnerships also often involve students, giving them opportunities to develop industry-relevant skills and positioning them for employment".

Canada's priority on R&D activity with academia as an economic development objective is emphasized within the HQSS RFP documents, including:

- a. The ITB Contract Terms and Conditions whereby multipliers are applied to cash contributions to academia for R&D activity at a standard 5 times rate.
- b. The award of up to 20% of possible Value Proposition Points for R&D Commitments with institutions in the Identified Market Segments.

The Rated Evaluation also reflects Canada's preference for identified VP Activities in the form of detailed and defined Transaction Sheets, represented by 20% of VIP.

The Industry Canada recognized valuation and crediting of proposed IT transactions directly impacts the cost and risk to achieve IT – VIP Commitments, and hence bid price.

Upon contract award, the bidder is required to fulfil its 100% obligation with approved Transactions, (which may have an applicable multiplier), though the requirement to "Carry out each and every Transaction as per the Transaction sheet list", excerpted from the Bidders proposal into the ITB Contract.

There appears to be an inconsistency between the assignment of Value Proposition Points for VP R&D Commitments and the recognized valuation of defined R&D Transactions for evaluation purposes. (See Volume 1, Annex B, Appendix BE, Attachment BE1, Article 3.2 Evaluation of Transactions, R&D Transactions "will only be evaluated based on the actual dollar value of the business activity",)

Request:

Will Canada permit the multiplied value of R&D activity (in IMS areas) with academia at the standard five times multiplier for the VPP score for the Identification of Defined VP Activities? If not, please acknowledge that in order to achieve the maximum VPPs in the Identified Transactions Section the bidder would be required to propose greater than 100% defined transactions. Further, as per Volume 1, Annex A, Appendix AA, ITB BIDDERS INSTRUCTIONS AND REQUIREMENTS, please confirm that the Bidder is required to "achieve Transactions involving Research and Development."

Response:

As indicated in Article 3.2.4 of Attachment BE1 to Appendix BE to Annex B to Volume 1, the Transaction Sheets submitted in the Proposal will only be evaluated based on the actual dollar value of the business

activity, measured in Canadian Content Value. Multiplier credits are only considered after contract award and are subject to review and verification before they are approved.

As indicated in Article 6.5.1 of Appendix AA to Annex A to Volume 1, the Bidder's Proposal should include the Bidder's commitment to achieve Transactions involving Research and Development within the Identified Market Segment. While this is not a mandatory requirement, Bidders must include a R&D commitment statement expressed as a percentage of the contract value to be eligible to receive Value Proposition Points for this criteria. For details on the rated evaluation methodology for the Research and Development Value Proposition criteria, see Article 4.2.3 of Attachment BE1 to Appendix BE to Annex B to Volume 1.

Question #414

Reference:

Volume 1, Appendix AA – HQSS Acquisition – Proposition ITB Requirements, Article 6.6.3, states that `VP Points will only be awarded for the Capacity to Export section if Bidders can demonstrate that each of the Capacity to Export Components has been fulfilled. Bullet 3 specifies required documentation which provides evidence that current Canadian-based operations have a World Product Mandate.

Volume 2, Annex D, HQSS Acquisition Resulting Contract – ITB Terms and Conditions; and, Volume 3, Annex D, HQSS ISS Resulting Contract – ITB Terms and Conditions, Article 1.1.49, defines World Product Mandate as:

“World Product Mandate” means a long-term supplier relationship between the Contractor or an Eligible Party and a Canadian Company, whereby the Canadian Company has been legally authorized to carry out and has sole responsibility for specific activities including the design, development, Intellectual Property, manufacture and marketing related to the supply of products, components, modules or services destined for the domestic and world markets.”

Request:

It is our understanding that Canada seeks to maximize new and expanded export market development opportunities for Canadian industry as a result of the HQSS Project. New or expanded initiatives with Canadian-based operations can take many forms such as partnerships, product developments, joint R&D, IP transfer and licenses, formalized supply relationships, etc.

Will Canada permit the award of value proposition points for export market capacity development which has or will be provided in the form of Global Value Chain activity (as defined under the previous Industry Canada standard IRB Terms and Conditions v3 Article 8.2.4)?

This approach is much less prescriptive to industry whilst maintaining opportunities for Canadian-based industry to work with the Prime and its Eligible Parties to achieve the objectives of Canada -- accessing new or expanded target markets, and increasing export sales through new or enhanced channels to market. Further, a GVC approach permits industry flexibility to develop enhanced supply relationships to the benefit of Canadian-based industry, and avoid possible compliance issues with the regulations of other nations.

Response:
