Response to Inquiries:

1. WR Meadows has submitted Eco-Coat, Cera-Rod and Pourthane NS for product approval.
Response: The proposed products are acceptable as per Section 03 10 00 and Section 03 30 00. Where backer rod (Cera-Rod) is used, it shall not replace any pre-mould joint fillers (bituminous impregnated fiber board or sponge rubber). A 'board-shaped' filler shall be used.
2. Appendix A, Paragraph 3.19. Tilework specifies Floor tile and a wall tile, plan A-003 Finishes plans does not have any Ceramic tile indicated, there are also no interior elevations if wall tile is required.
Response: Refer to Addendum below.

Architectural Addendum A3

1. **Add Appendix A Section 3.19.1(h)**
 - h. Scope of Work:
 - 1) Staff Kitchenette – Room 106 – tiled wall between counter and upper cabinets
 - 2) Shower – Room 107
 - a. Provide tiled shower walls and pan or a prefabricated fibreglass shower stall. Ceiling shall be tiled or be part of the prefabricated fibreglass shower. Walls and ceiling outside the shower stall shall be tiled. Floor shall be as indicated on drawings.
2. **Replace Appendix A Section 3.23.11(f) & (g) with:**
 - f. Drywall on uninsulated space shall be treated as exterior drywall and shall be moisture resistant.
 - g. Products:

1) Detention Galvanized Metal	INT 5.3D – G3
2) Detention Interior Drywall	INT 9.2N – G3
3) Detention Interior Ceiling	INT 9.2N – G3
4) Galvanized Metal	INT 5.3M – G3
