### **QUESTIONS AND ANSWERS FROM JULY 14<sup>TH</sup>, 2015**

#### **Question 1:**

Can the requested services for the above referenced solicitation be provided by more than one resource?

#### **Answer 1:**

Yes there could be more than one provider - they would have to be security cleared (currently takes 6 to 9 months) and meet the education requirements.

#### **Question 2:**

Is there an estimation of the number of assessments (cadet screening, specialized and occupational health) that are required to be completed within a week?

#### **Answer 2:**

Average is 35 to 40 assessments per week, dependent on type of assessment - pre-screening, cadet, critical response, administrative, occupational.

#### **Question 1:**

Are the requested services for the above referenced solicitation currently being provided or have they been provided previously? #### **Answer 1:**
