The Canadian Coast Guard, St. John's, Newfoundland has a requirement for supply cabinets for the Canadian Coast Guard Ship Ann Harvey. The CCGS Ann Harvey is a seagoing vessel and cabinets shall be specifically rated for mobile/moving platforms.

This amendment is raised to answer the following supplier questions:

3.1.16 – There should only be 1 – 4” Drawer not 2.

We cannot add another drawer to this height as it will not fit inside the housing.

As per specification. New height dimension of 3.1.15 shall be 66” maximum to accommodate two 4” drawers.

3.1.12 – For the 3 – 4” drawers, they should come with 25 compartments not 24.

Specification stated minimum of 24 compartments so 25 is acceptable.

I also have several questions that will need to be addressed:

Other Notes/Concerns:

3.1.1 – It's noted that the cabinets shall be dark blue in color.

The color: Classic Blue (052) was discussed when I sat down with Canadian Coast Guard. See attached color chart.

Knowing the **RAL** # in advance is important as it's helps the Vendor price the project. Not all shades of paint is standard and could be different pricing from suppliers.

As per specification. CG cannot accept color until contract awarded. CG will choose standard color from supplier that is blue.

3.1.2 – The Epoxy type paint is available but please be advised that **Epoxy paint is not UV resistant.**

If you go with Epoxy paint and the cabinets are exposed to sunlight or even room lighting a lot your blue will eventually fade a lot.

We can offer a Hybrid type of paint that is a mixture of epoxy & polyester. This type of paint is more stable and gives you better results overtime.

Also, Epoxy paint has a **longer lead time** & the shade of Classic Blue for example will not be exactly like it's shown due to the different type of paint.

In regards to the scratch & corrosive resistant factor, the Hybrid type of paint is slightly less resistant but only slightly.

CG will accept hybrid epoxy paint.

3.1.10 – For the Angle Bar requested, are you asking for cabinets to be anchored to floor or wall?’

Cabinets shall be anchored to floor. CCGS Ann Harvey has angle bar welded to deck and supplied cabinets shall be capable of being mounted to this existing angle bar.

3.1.12 – Warranty – In regards to lifetime warranty, is it expected for the life of the boat, 25 years etc.

Our supplier does offer lifetime warranty on their rolling mechanism but where the cabinets are going on a boat, that raises a lot of questions.

For example, if these cabinets are exposed to salt water and causes issues with the cabinets, how will this affect the warranty?

25 years is acceptable for lifetime warranty. There is no salt water contamination as this is an internal space.

3.1.6 – For the labels & clear coverings, do you want them on every divider inside the drawer?

Or do you want 1 label on outside of drawer or other?

Labels with clear cover shall be fitted on outside of drawer and dividers shall be labelled as well.

3.1.3 – Locks – see response from manufacture – Is this acceptable?

Normally what we can find on the market are locks with Zinc die cast cylinders with stainless steel scalping on the visible face of the lock.

As far as we know there are no locks that are entirely made of stainless steel.

Also keys are made of steel with a zinc coating.

Locks shall be stainless steel or corrosion resistant equivalent. Zinc coated is acceptable with stainless steel face.

3.1.13 – Cabinets to be supplied within 4 weeks of contract award.

Realistically it will be 8 weeks due to extent of project & the many manufacturers shutting down for summer break.

Is this acceptable?

Half of cabinets requested shall be supplied in 4 weeks with remainder in 8 weeks.

Is offloading of the product once it arrives requested or offloading by your staff?
