

This Amendment is raised to respond to supplier questions, provide MS Word versions of Annex B and modify Annex B Section 1.

Question 1: With regards to the Request for Qualification referenced above, could you please provide a Word document version so that interested parties could complete Annex B as requested.

Answer 1: Word versions of Annex B, amended as per Answer 4, are now attached in English and French.

Question 2: Could you confirm or infirm that an international supplier must be registered under Controlled Goods Program (CGP) for the CSC project?

Answer 2: Registration in the CGP is restricted to Canadian companies. CGP registration is not a requirement for Canadian suppliers in SRCL W847S-150033. Registration in the CGP is a requirement in SRCL W847S-150033A and SRCL W847S-150036 for Canadian suppliers or Canadian affiliates of international suppliers nominated to be the single point of contact with Canada for communications related to post-RFRE Industry Engagements and any subsequent bid solicitations. The security requirements for international suppliers listed at Annex A would apply to international suppliers and do not identify a requirement to register in the CGP.

Question 3: We have noted on Canada's Buy and Sell website a notice of an amendment to the CSC RFRE dated yesterday July 13th. However the attached file appears to be the original RFRE released last week. We wish to ensure that if there is a RFRE amendment that has been released that we receive a copy. Please confirm if an amendment was released and if so provide a copy. Or confirm that Buy and Sell in reporting an Amendment is in error. Thank you as your response is much appreciated.

Answer 3: The amendment dated July 13th was to correct a spelling error in the website notice. The attached RFRE was not amended on July 13th.

Question 4: At Annex B, Section 1 (Certification Form), at the end of this form, there are spaces for two signatures. Is it intended that signatories from both the legal entity that meets the mandatory criteria and the Canadian affiliate will sign here?

Answer 4: The signature of the legal entity that meets the mandatory criteria is required to sign Annex B Section 1. The signature of the Canadian affiliate is not required.
