This amendment has been raised to respond to a bidder question and to modify the following:

**Question # 1:**

In regards to part number 213038, we do not have sufficient information to determine what this part is or where it is used. We require what Honeywell technical publication lists this part number or provide the top level part number where it is installed.

**Answer # 1:**

Part number 213038 is part of the Stabilized Horizon Reference System, AN/SJM-501 (HFX Class Ships). This would be the Canadian variant of the US version (5119-SJN-501) system. As per the higher assembly, please refer to C-5472/SJN, which is the source data for this system.

Bidders who are incorporated, including those bidding as a joint venture, must provide a complete list of names of all individuals who are currently directors of the Bidder.

Bidders bidding as sole proprietorship, as well as those bidding as a joint venture, must provide the name of the owner(s).

Bidders bidding as societies, firms or partnerships do not need to provide lists of names.

### **5.2.2 Federal Contractors Program for Employment Equity - Bid Certification**

By submitting a bid, the Bidder certifies that the Bidder, and any of the Bidder's members if the Bidder is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list ([http://www.labour.gc.ca/eng/standards\\_equity/eq/emp/fcp/list/inelig.shtml](http://www.labour.gc.ca/eng/standards_equity/eq/emp/fcp/list/inelig.shtml)) available from Employment and Social Development Canada (ESDC) - Labour's website.
