Q 7 A) An amount of 50K\$ has been included for surveying/bathymetric readings. Does the 50K\$ cover only the professional fees or also the travelling expenses? Where do the travelling expenses (for the readings) need to be separately indicated (on the lines that need to be completed)?

B) **ANNEX C – PRICE PROPOSAL SHEET page 8 of 12** (*page 3 of 5, following amendment 002*):

“With respect to the services limited by expenses, there is a division of costs to be presented in the price proposal sheet, page 8 of 12. Are these amounts foreseen for the sub-contractor of activities AS1 and AS4 in the expense amount? If they are not, where must they be indicated in the proposal?”

A 7 A) The AS1 and AS4 services are subjected to an expense limit and must include the professional fees, travelling expenses and all other fees.

B) The lines to be completed for the expenses (page 8 of 12) are for the other services, such as the fixed price services required (SR) and the services based on time AS5.
