**Question 1**

*Section IV: Additional Information* is noted on page 14 of 97 of the RFP but is not reflected in Part 3, section 1. *Bid Preparation Instructions*. Can AANDC kindly confirm that only one hard copy of Section IV: Additional Information is required with Bidders' submission?

**Answer 1**

Under PART 3, page 12 Section II: Management is deleted in it's entirety as it is covered under M1 and Section III: Financial Bid, page 13 is changed to Section II with Section IV: Certifications now being changed to read Section III: Certifications.

Part 3, article 1 remains the same.

**Question 2**

Bidder's technical score for R1 says "**70**". Should this read "**100**"?

**Answer 2**

If you look at the bottom of R1 you will see the Maximum Technical Points which is 100, then you will see Minimum Pass Mark which is 70 points (you need 70% to pass) and then you will see Bidder's Technical Score which is achieved once the evaluators have reviewed the proposals and has to be at least 70 out of 100.
