Here is one other question which we have received until now:

Question 4: Dimensions **1/2"** (7 1/2", 9 1/2", and 11 1/2") for items # 1 to 3 of Annex B - Basis of Payment are different from those indicated in table 820c **1/4"** (7 1/4", 9 1/4", 11 1/4") of the attachment to the Invitation to Tender named "Western Red Cedar". Please Clarify?

Answer 4: Dimensions indicated in table of Annex B - Basis of Payment are those required at delivery so after planing, drying and treatment. Many of our dimensions are not standard and therefore not indicated in Table 820c which only shows standard dimensions. Also, please note that corners of the finished wood shall not be rounded.

All other terms and conditions of the Invitation to Tender remain the same.
