Question 3 : For the RFP W7701-155980/A, can you confirm that we can use a government and federal agency as part of our Joint Venture. These could be agencies such as NRC, NRCan or institutions such as universities and colleges, etc.?

Answer :

The "2003 (2015-07-03) Standard Instructions - Goods or Services - Competitive Requirements" which form part of RFP W7701-155980/A provide that the Bidder has to demonstrate that it has the legal capacity to contract if requested by the Contracting Authority. Typically, departments cannot contract with Crown corporations, unless the legislation of the Crown corporation provides otherwise. PWGSC is not in a position to advise as to the legal capacity of joint venture partners to contract with the Crown. We encourage bidders to seek appropriate guidance or legal advice to determine whether they have the necessary legal capacity to submit bids.
