1. This solicitation is hereby amended to provide the following questions and answers

Question 5 . Reference is being made to ANNEX "A" MANDATORY REQUIREMENTS, item 1. "Units must have a cover and 20 clear pages / 40 pockets"

Question 5 (a): can you please explain this requirement in more details? Do you need the binders to be supplied including one Letter size cover page (punched and inserted into the binder) + 20 clear Letter size paper sleeves (inserted into the binder)?

Answer 5 (a). No Cover page required, logo will be on front of the imitation leather horizontal binder and would have to be made of a sturdy material that will hold 20 clear pocket pages in total which would house 40 certificates (20 back to back).

Question 5 (b). Is there any prints required to be done on the Cover page?

Answer 5 (b). YES

Question 5 (c). We are not yet clear about what 40 pockets mean? because each clear page sleeve will accommodate only one page (printed on both sides) for display purposes. Do you mean by 40 pockets, that you will insert two pages (only one side printed) into each sleeve?

Question 6. What is the color of your choice for the Binders?

Answer 6. Black or whatever colour would look nice with the logo (attached)

Question 7. Can you provide the English and French designs for the imprint, and to advise the location, Colour, and size of the imprint to be done on the Binders ? Middle of the binder.

Answer 7. Size of image is 4 ½ X 6 Inches, located in the centre of the binder with two poppies in two of the corners (if possible) - see attached (English and French)

Question 8. Do you require the easel pages to be landscape or portrait style?
