### SI02 ENQUIRIES DURING THE SOLICITATION PERIOD

- 2) To ensure consistency and quality of the information provided to Bidders, the Contracting Officer shall examine the content of the enquiry and shall decide whether or not to issue an amendment.
- 3) All enquiries and other communications related to this bid sent throughout the solicitation period are to be directed ONLY to the Contracting Officer named on the Invitation to Tender Page 1. Failure to comply with this requirement may result in the bid being declared non-responsive.

### SI03 OPTIONAL SITE VISIT

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for a tour of the work site. The site visit will be held on **August 12<sup>th</sup>, 2015 @ 1:00 pm at the RCMP Drayton Valley Detachment located at 5409 Industrial Road in Drayton Valley, AB.** Bidders <u>must</u> notify the Contracting Authority **two (2) days** before the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend, if no notification is provided the site visit will be cancelled. Bidders may be requested to sign an attendance form. Bidders who do not attend or send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

### SI04 REVISION OF BID

### SI06 INSUFFICIENT FUNDING

In the event that the lowest compliant bid exceeds the amount of funding allocated for the Work, Canada in its sole discretion may

- a) cancel the solicitation; or
- b) obtain additional funding and award the Contract to the Bidder submitting the lowest compliant bid; and/or
- c) negotiate a reduction in the bid price and/or scope of work of not more than 15% with the Bidder submitting the lowest compliant bid. Should an agreement satisfactory to Canada not be reached, Canada shall exercise option (a) or (b).

## SI07 BID VALIDITY PERIOD

- 1) Canada reserves the right to seek an extension to the bid validity period prescribed in BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders shall have the option to either accept or reject the proposed extension.
- 2) If the extension referred to in paragraph 1) of SI07 is accepted, in writing, by all those who submitted bids, then Canada shall continue immediately with the evaluation of the bids and its approvals processes.
- 3) If the extension referred to in paragraph 1) of SI07 is not accepted in writing by all those who submitted bids then Canada shall, at its sole discretion, either
  - (a) continue to evaluate the bids of those who have accepted the proposed extension and seek the necessary approvals; or

### SC01 SECURITY REQUIREMENT FOR CANADIAN CONTRACTORS

1. Ensure that all persons working on site hold a valid Facility Access 2 security clearance issued by the RCMP Departmental Security.

### SC02 SUBMISSION OF BID

1. Copies of first page of amendment(s) to be submitted with bid, duly signed/initialed, verifying proof of receipt.

### SC03 INSURANCE TERMS

- 1. Insurance Contracts
  - (a) The Contractor must, at the Contractor's expense, obtain and maintain insurance contracts in accordance with the requirements of the Certificate of Insurance. Coverage must be placed with an Insurer licensed to carry out business in Canada.
  - (b) Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.   - (a) Before commencement of the Work, and no later than thirty (30) days after acceptance of its bid, the Contractor must deposit with Canada a Certificate of Insurance on the form attached herein.
  - (b) Upon request by Canada, the Contractor must provide originals or certified true copies of all contracts of insurance maintained by the Contractor pursuant to the Certificate of Insurance.
- 4. Insurance Proceeds

In the event of a claim, the Contractor must, without delay, do such things and execute such documents as are necessary to effect payment of the proceeds.

## Annex A Scope of Work Drayton Valley RCMP Detachment Grading, Drainage Repairs & Interior and Exterior Modifications

## Scope of Work: (May require after hours work)

Work under this contract will involve, but is not limited to the following for the Royal Canadian Mounted Police (RCMP): Supply all labour, material, tools, equipment, transportation, and supervision necessary to to complete the Grading, Drainage Repair and Interior and Exterior Renovation at the RCMP Drayton Valley Detachment, Drayton Valley, Alberta, as per the following:

## Exterior:

- Repair all potholes and deterioration in the Parking Lot.
- Install rainwater leaders on all corners (200mm).
- Exterior painting of metal siding.
- Re-grade & replace sod & topsoil around perimeter of building (1.5m).

### Interior:

- Move wall in room 001, two meters into room 002, includes millwork sink and accompanying plumbing and electrical.
- Flip the orientation of the door for room 002.
- Remove doorway between room 003 and 004, seal opening with concrete block apply high build coating.
- Install doorway between patrol corridor and room 004 (rated STC 47).
- Install viewing window c/w internal shutter (rated STC 47).

## **Specification:**

## **Re-grading of site:**

- 1. Improve grading to 3% close to building with 100 mm of top soil and sod, approx. 1.5m away from building.
- 2. Cut shrubs back to allow for proper grading close to building.

## **Exterior Painting:**

- 1. Commercial grade paints to be used.
- 2. Paint color to be selected by RCMP.





### Wall Move in Room 001:

- 1. Any impacted flooring to be repaired or replaced
- 2. Hose bib plumbing to be covered if needed, any shut off valves to be left exposed.
- 3. Affect electrical and/or Ducting is to be included and relocated.
- 4. New constructed wall to be of 2 x 6 metal stud construction insulated to R40.
- 5. Finish and paint new wall, color to be selected by RCMP

### Cabinetry in Room 002:

- 1. Reconstruct commercial grade cabinetry, with existing number of shelves to remain.
- 2. May be required to be custom 19mm birch plywood construction, melamine drawers, 3mm PVC edging.

### Secure Window:

- Aluminum extrusions from alloy AA6063-T.5 (aluminum frames) and AA6061.T6 (sliding tracks), anodizing quality. Engineered fixed acoustically sealed aluminum framed fixed glazed window unit with integral horizontal pivoting aluminum louvre; factory glazed and sealed with following make-up: one (1) Window to be 18" W x 24"L.
- 2. Perimeter frame: extruded aluminum 35 mm nominal depth, width to suit glazing thicknesses as shown with 63.5 mm clear air space.
- 3. Sound transmission class for complete unit: stc 51(estimated).
- 4. Outside and inside glazing: clear laminated glass meeting CAN/CGSB-12.1-M90, 10 mm thick, 63.5mm Airspace.
- 5. Horizontal pivoting louvre system, and operated tilting mechanism concealed in the frame with louvre control knob, frame mounted on Corridor side (to be of plastic).
- 6. Finish of exposed aluminum components: baked enamel in color selected by RCMP Detachment Commander or Delegate from manufacturer's standard range of colors.
- 7. Seal both sides of observation window with paintable acoustic sealant.
- 8. Acceptable products: Unicel Inc.; Vision Control Products.

### Window Installation:

- 1. Install in accordance with CAN/CSA-A440-M90.
- 2. Arrange components to prevent abrupt variation in color.





### Sill Installation:

- 1. Install metal sills with uniform wash to exterior, level in length, straight in alignment with plumb upstands and faces. Use one piece in lengths at each location.
- 2. Cut sills to fit window opening.
- 3. Secure sills in place with anchoring devices located at ends and evenly spaced 600 mm oc in between.
- 4. Fasten drip deflectors with self tapping stainless steel screws.
- 5. Maintain 6 to 9 mm space between butt ends of continuous sills.

### Caulking:

- 1. Seal joints between windows and windowsills with sealant. Bed sill expansion joint cover plates and drip deflectors in bedding compound. Caulk between sill upstand and window-frame. Caulk butt joints in continuous sills.
- 2. Apply sealant in accordance with manufacturer's directions. Conceal sealant within window units except where exposed use is permitted by Engineer.
- 3. Polyurethane foam insulation around entire window frame. Inject polyurethane foam insulation from exterior side of window frame until foam is exposed on interior side of window frame. Trim cured polyurethane foam insulation prior to caulking finishing.

### Acoustical sound testing:

1. Once the window has been installed and caulked has been the room must be sound tested to see if the window achieves an STC 46 rating.

### Acoustic Steel Door and Frame Accessories:

- 1. To include complete assembly package to meet STC 46.
- 2. Door thickness 16ga, fire rated acoustical door.

### **Concrete Block:**

- 1. Standard concrete block units to: CAN3-A165.1M94.
  - a) Cells: H/15/C/M.
  - b) Size: modular 200 x 400 x 200.
  - c) STC rated concrete block walls: fill block cavities with grout for the full height of walls.

## 2. Finishes

- a) Color to match existing.
- b) Standard of Acceptance: Duroplast 100 (Duroplast 100, Stonhard VSC).
- c) Block filler: Epoxy as approved by high build coating manufacturer.
