This Amendment 002 is raised to answer questions from potential bidders:

Q1) In the financial evaluation section, hourly costs are asked for on a First Nations assistant. Most First Nations Groups charge out on a daily rate and differs significantly. How would you like us to get the hourly rate? Could a provision be stated on the bid that this is an estimate hourly rate and may differ between First Nation Groups?

A1) It is up to each bidder to place a hourly rate for each speciality that is being asked for. Bidders are to bid in accordance with the criteria of the RFP. Failure to bid in accordance with the instructions of the RFP will deem your bid non-responsive.

Q2) In the technical section it mentions the CV can only be 2 pages long per person. Later it mentions in section 3.4 to 3.6 that for the Point Rate Criteria section that each can only be 2 pages. Is this ontop of the 2 pages for the CV?

A2) Yes.
