### Amendment 3

This amendment is issued to answer questions from potential bidders.

#### Questions

**Q2.** Do you know if the precast barriers are pinned in?

**A2.** The precast barriers are pinned to each other.

**Q3.** Are you able to provide a highlighted drawing showing what is to be paved? Would like to know if ramps are included, the overpass, etc..

**A3.** No drawing is available. Yes, all four ramps are included at an interchange as directed by the Departmental Representative. Overpass at an interchange is excluded unless directed by the Departmental Representative.

**Q4.** Please can you also confirm that we are able to remove the precast barrier in one go, or do we have to remove and pave in sections?

**A4.** Contractor is allowed to remove the barriers in one go.

**Q5.** Can you clarify the paving limits, are we to do tie-ins to the ramps at the intersections of Banff Ave and Norquay Road where they meet the Trans-Canada or are the ramps to be paved?

**A5.** Please see response to #3 above.

**Q6.** Please confirm the exact start and finish locations for the overlay in relation to the intersections

**A6.** Paving at intersections is to extend to the right-of-way line as directed by the Departmental Representative.

**Q7.** With regards to Addendum 1, where is DSP2 which details the Mannix Pit Plan and the Pavement Marking spec, didn't see this attached.

**A7.** Please see attached.

**Q8.** Can't find the Milling Detail 17, please send through.

**A8.** Please see attached.

**Q9.** Is Annex C Attestation Form required with tender or is this after award?

**A9.** After award.

**Q10.** Is shouldering with provided Rap/Gravel mix part of this scope? If so where are the locations/quantities and where does this get paid?

**A10.** It is part of the scope as agreed with the Departmental Representative on site and will be paid under "Lump Sum Item 3 – Prime Cost Sum."

**Q12.** Spec says Rumble strips to be installed along Hwy 16 - please confirm typo?

**A12.** Milled Rumble Strips to be installed along Trans-Canada Highway as directed by the Departmental Representative.

**Q13.** Spec has section on topsoiling and seeding - please confirm not part of scope.

**A13.** If determined necessary, this work will be undertaken by the Contractor and will be paid under "Lump Sum Item 3 – Prime Cost Sum."

**Q14.** Please confirm we are only moving the barriers once (initial move and reinstall) as spec says they could be installed for traffic control.

**A14.** Contractor is allowed to move the barriers once.

**Q15.** Are there any Parks Canada source pits outside of Banff National Park boundary that could be used for this project?

**A15.** No.

- Q16.** Do you happen to know locations and run lengths of the barrier to be removed and stockpiled? Also the barrier type?
- A16.** Existing barriers are located on the Trans-Canada Highway between km 13-17. Barriers are 810mm tall precast concrete barriers.

**All other terms and conditions remain unchanged.**
