This Amendment 001 is being raised to extend bid closing date to August 14, 2015, provide answers to the questions that have been received, and incorporate the following information into Solicitation M8500-14R100/A:

Question 1: Will there be technical drawings, specifications and/or a viewing sample available to bidders as none are available in the Request for Standing Offer?

Answer 1: No, there are no technical drawings or viewing samples available for this item. A brand/part number of a commercial off the shelf product could be provided.

Question 2: Do you have a manufacturer's part number so I can at least see which sling it is? Or get some pictures?

Answer 2: An example of an item that may meet this requirement is:

Tactical Link Stealth Bungee Single Point Quick Detach (QD) Tactical Sling

Product #: STLTHBUNG-1PS-DE (Dark Earth Colour) or
Product #: STLTHBUNG-1PS-BLK (Black Colour)

Question 3: Is there a specification for the webbing? I.e. Military spec reference number.

Answer 3: No, a specific military specification or reference number is not being provided.

Question 4: Can equivalent products be used instead of ITW products?

Answer 4: Yes, an equivalent product could be supplied. The specifications with respect to equivalency must be provided by the vendor.

Question 5: Is the Quick Detachable flush cup swivel connector to include the cup socket which mounts directly to the firearm or strictly the swivel connector only?

Answer 5: Swivel connector only.

Question 6: "Webbing must be available in 2 colours" – Reference Design and Sizing – Item #4 - Is there a firm amount of each colour to be produced. None are listed in the RFSO?

Answer 6: No, a firm quantity is not provided at this time.

Question 7: No neck pad sleeve for the webbing is listed in the document. Is one to be supplied with the sling? That is standard on many slings.

Answer 7: A neck pad sleeve is not a required feature.

Question 8: Is this Request for Standing Offer open to manufacturers to build the product?

Question 8: No, the requirement is for existing off-the-shelf product.

Question 9: Can the 7 day sample period be amended to 21 days to provide the manufacturer reasonable time to prepare a sample?

Question 9: Yes, the sample period could be extended if needed. 21 days is an acceptable time period.

Question 10: Is it absolutely necessary to have the quick release buckle's minimum external dimension 1.5"? The reason we don't have 1.5" hardware on the 1.25" webbing is because the two widths would not fit optimally and would be sloppy at the junctions (where the 1.25" webbing meets the 1.5" hardware). Is it the outer width of the buckle that needs to be 1.5" while the 1.25" slot size would be correct for the 1.25" webbing?

Answer 10: Yes, it is the outer width of the buckle that needs to be 1.5", to allow for the buckle to be of a sufficient size to be easily grasped to release these plastic hardware components.
