Amendment 002 is being incorporated to answer questions/notes from the site visit as follows:

Tour was conducted by Rob Tonary from NSPI

1. Question: Are there different grades of coal?

1. Answer: Grading is based on BTU ratings. PWGSC has been buying mostly 12,000 BTU.

Following facts were discussed:

-R. Tonary showed the area where screeners are typically set up. He said that in addition to this area they some times need to be moved to the long term storage site area (on Lingan site but in a different area from where the screeners are usually set up.

-Ron advised that on occasion the screeners also may have to be moved due to NSPI operational requirements

2. Question: Discussion arose as to possible need for GPS on equipment?

2. Answer: No, GPS is not required on equipment.

Following facts were discussed:

-With regard to the fines, (remains of raw material that was put into screener after yield removed) stated by R. Tonary (NSPI) that sometimes the fines have to be trucked back to the long term storage area. NSPI confirmed today and said this would happen infrequently and they normally take measures to try to mitigate this from happening.

3. Question: Why is a dozer required?

3. Answer: A dozer is required because the coal has to be pushed to the screeners.

4. Question: What is the gradation of the coal meaning the size range of the coal particles or lump.

4. Answer: It was suggested that information may be available through NSPI however, upon further investigation it was determined that the size of the coal particles or lumps are not a parameter they measure or are concerned with, as they crush the coal before it goes into the plant. NSPI advises that visual inspection is the best way to make an assessment of the sizing.
