This Amendment 003 is raised to answer questions and make changes to the Solicitation# W0142-15X046/B as follows:

A. Question & Answer

Question#1: Is this item#659 a 4 oz or 40 oz?

Answer#1: It is 4 oz

Question#2: Some items is unable to supply, can these be removed?

Answer#2: No.

Question#3: There are items greater than 15% difference between requested pack and offered pack - size, do you accept them?

B. Amendment to PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. Article 4.1.2.2 Mandatory Financial Criteria

Delete: The Offeror must complete and submit with its offer, Annex B - Section A - Basis of Payment (Excel File). Firm pricing must be provided for at least 80% of the items listed to be considered for a Standing Offer. Failure to provide a minimum of 80% pricing will render the offer non-compliant without further consideration being given.

Insert: The Offeror must complete and submit with its offer, Annex B - Section A - Basis of Payment (Excel File). Firm pricing must be provided for a minimum of 80% (there are 710 items listed, Offeror must bid on at least 568 of the 710) of the items listed to be considered compliant. Bids will be evaluated on like items only.

Failure to provide a minimum of 80% pricing will render the offer non-compliant without further consideration being given.

Offeror is requested to provide pricing as per unit of issue requested. It is the responsibility of the Offeror to provide conversion to the unit of issue requested. For example: if an item of issue requested is in weight, and the offered item is in volume or unit, the Offeror must provide conversion to weight. Failure to do so may render the bid non-responsive without further consideration.

2. Article 4.1.2.3 Pack or Unit Size

3. Article 4.1.2.4 Mandatory Items
