OBJET DE LA PRÉSENTE MODIFICATION - THE PURPOSE OF THIS AMENDMENT IS TO GIVE EFFECT TO THE FOLLOWING

Q1. On drawing Mo2, Item CB5 split dust cover

Details 1: no explanation on the hole (hole or ball inside the stainless steel lid)?

R1. The details of the part CB5 are supplied to the drawing Mo3. In the center of the part, there is an opening to give way to the top spacer (part CB6). And the holes which we can see inside plates are holes for bolts M10 used to fix the lid because this is made in 2 parts. Holes are located in the connectors of 20mm of width x 22mm welded on the top plate of 5mm x by 356 mm diameter.

Q2. Item M6 on the contract item list

We want to know if you can recommended manufacturers of pivot and not by bearing?

R2. For the complete assembly of the central pivot (CB1 to CB7), this is a custom made assembly and must be made by a workshop. Because of the number of workshop who can supply this working type of work, we are not able to recommending manufacturers

Q3. Concerning the call for tenders mentioned above, please specify the sections of the bridge to be painted. Only the new parts have to be paint in shop without any jobsite painting, or the complete bridge must be cleaned and re paint. This item is ambiguous in the tender's documents.

R3. In a general, the new parts have to be paint in shop and correction must be made in places if damaged by the works and on the existing elements in touch with the new parts

1. Replacement of the central pivot

See article 2.5 of the section 45 00 02 "mechanical Works - general "of specs.

2. Repair of the structure of steel

See the note 8 to the drawing Bo3, as well as the articles 1.1.1.6.16 and 1.1.1.6.17 of the section $01\ 29\ 00$ "Payments" of specs.

3. Put back to the good alignment of the rail of the balance wheels

See article 2.5 of the section 45 00 02 "mechanical Works - general" of specs.

4. Replacement of sections damage by the rail and re align

See article 2.5 of the section 45 00 02 " mechanical Works - general " of specs.



5. Installation of counterweight

See the note 2 on drawing Bo4.

6. Repair of concrete wall - west abutment

For L76x76x6.4, see article 1.1.1.6.13.3 of the section 01 29 00 "Payments" of specs

See elevation 1 on drawing Bo4 for the plate anchored in the wall.

7. Repair of concrete under the supports of the bridge, replacement of anchoring supports

No painting needed on existing support plates.
