## AMENDMENT 001

The purpose of the Amendment 001 is to amend the Request for Proposal.

**1** – The amendment applies only to the French version of the Request for Proposal.

**2-** Insert the following text at the beginning of the article **3. Former Public Servant – Competitive bid** in *Part 2*:

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPSs, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

**3-** Amend **7.1 Basis of Payment / (iv) Travel and Living Expenses / a. / i** in *Part 7* as follows:

i. services provided within the **Montreal Metropolitan area and within the Quebec City Metropolitan area** ~~the metropolitan area~~ ; and

**4.** Amend the article **3.2 Intermediate real property project manager / b** of the *Annex A – Statement of Work* as follows:

b) The resource has a minimum of **80 points** ~~70 points~~ according to the Project Manager for Real Property Flexible Grid – intermediate

**5-** The amendment applies only to the French version of the Request for Proposal.

**6-** Amend the **Note 3 of the criterion 2** in *Attachment 2 – Mandatory and point rated technical criteria* as follows:

Note 3: Only resources who meet the mandatory technical criteria will be evaluated against the point-rated technical criteria. Resources who do not meet the mandatory technical criteria cannot be included in the **contract** ~~standing offer~~, if applicable.

**7-** Amend the **Note 3 of the criterion 3** in *Attachment 2 – Mandatory and point rated technical criteria* as follows:

Note 3: Only resources who meet the mandatory technical criteria will be evaluated against the point-rated technical criteria. Resources who do not meet the mandatory technical criteria cannot be included in the **contract** ~~standing offer~~, if applicable.

**All other terms and conditions remain the same.**
