**Description of the work:**

The objective of this contract is to acquire a System Administrator – Level 3 in Linux, Apache, Tomcat and JBOSS to provide, on an as and when required basis, continued operational support for the e-School and the ILMS (Integrated Learning Management System). Furthermore, the resources will be required to support the upgrade of ILMS (Saba Enterprise) from version 6.1 to 7.3 and provide expert advice on best practices on system administration and support in a Linux-based environment using Apache, Tomcat and JBOSS.

The system administrator will provide support and monitor existing production systems. He will provide expert advice on how to improve stability and performance of the current and/or upgraded systems. He will create and update documentation of the current and future state of the systems and will create scripts to automate repetitive tasks. He will also participate in meetings with the project team and Shared Services Canada (SSC) as and when required.
