Question 1:

Can you please confirm the color of each item of this request for Standing Offer.

Answer 1:

Item #1: 4173-DE - Ergo 18-Slot LowPro Ladder Rail Cover Bulk

We will require this item in either Black (4173-BK) or Dark Earth (4173-DE), the color will be specified at time of call-up.

Item #2: 4373-3PK - Ergo 18-Slot LowPro Ladder Rail Cover 3-Pack

We have determined that this item will not be required and all references should be removed from the solicitation document.

Item #3: BGV-MK46K - TangoDown Stubby Vertical Grip

We will require this item in either Black or Flat Dark Earth, the color will be specified at time of call-up.

Question 2:

The request for pricing is basically 1 each for 1 year plus two optional years with delivery to Regina, Saskatchewan, I'm guessing the RCMP will require various quantities for each item thru each year. Can you give any idea on minimum quantities that would be ordered, how many times a year.

Answer 2:

The estimated quantity required per item is 4000 units; 2000 for the first three (3) years and 1000 per option year as indicated in Part 1-General Information, Section 2 Summary. As noted in the RFSO under section 4.1 and 4.2, the period of the standing offer will be three years from the date of issuance with options to extend the period for up to two additional one-year periods.

The minimum call-up quantity per item listed in Annex A will be 100.

Question 3:

Can you please let us know if a bid submitted in US Dollars would be accepted, as per SACC M0222T

Answer 3:
