In three of the four A.9 Technical Performance Tables in Annex A - Requirement, the values for Stiffness (CD) and Stiffness (MD) are reversed from the values in the current standing offer E60PD-14PAPR. Would Canada please confirm the correct values?

Response no 3:

MD (Machine Direction) and CD (Cross Direction) refers to fiber alignment, paper stiffness is typically higher in Machine Direction as a result of this alignment of fibers. This requirement should not be confused with Long Grain and Short Grain which refers to the direction in which the paper is cut to size.

The values remain as specified.
