Nature of the Work:

- The work under this contract shall include the furnishing of all superintendence, overhead, labour, materials, equipment tools supplies, insurance and all things necessary for and incidental to the satisfactory performance and completion of all work.
- The demolition and removal of all existing timber components on Timber Bulkhead Wall and Timber Retaining wall.
- The supply and installation of new Timber Cribs Wharf and Deadman anchors including excavation for installation of cribs, geotextile and granular backfill.
- The supply and installation of shore protection rock

Familiarization with the site:
