This amendment is raised raised to delete the following text in the English version only of the original solicitation, as follows:

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

Delete the following text, which was inadvertently included, in accordance with the applicability of the North American Free Trade Agreement (NAFTA):

"(c) The evaluation team will determine first if there are two or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than two responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated."

The French version does not contain the equivalent text, and is therefore unaffected. All other terms and conditions of the original solicitation remain unchanged, including the closing date and time.
