Q3. What does Extended Pricing refer to and how do you calculate it?

A3. The extended pricing refers to the pricing obtained from multiplying the unit prices the bidder offers with the estimated quantities required(See pricing schedules). Should the bidder make a mistake in this calculation (Therefore creating conflicting prices between prices offered and prices evaluated), PWGSC will evaluate the bid by recalculating the extended price using the unit prices, and disregard the extended pricing calculated by the bidder. The Total Evaluated Price will be the aggregate of PRICING SCHEDULE 1: ROUTINE/SCHEDULED CLEANING and PRICING SCHEDULE 2: "AS AND WHEN REQUESTED" SERVICES.

Q4. How many people work per shift currently at any given time?

A4. Environment Canada has 5 people that work from 7am to 3:30 pm and 2 people that work 2:30-11pm, 7 staff in total.

Q5. How many employees work in the Environment Canada building?

A5. There are roughly 500-600 people located at the Environment Canada Building.
